

Introduction

The global response to the COVID-19 pandemic has been marked by unprecedented medical interventions, evolving scientific definitions, and staggering statistical outcomes. Between 2020 and 2023, both the virus and its associated treatments triggered worldwide shifts in healthcare, public policy, and human lives. The data presented here reveals critical facts surrounding the pandemic, vaccine developments, testing methods, and associated adverse effects. Personal losses and experiences further highlight the lasting impact on individuals and families.

Pandemic Data: Mortality Rates and Intervention Outcomes

According to the CDC in 2020, the chance of dying from COVID-19 (the annual flu) ranged between **0.02% and 0.15%**, depending on age. Splitting the difference, the average chance of dying stood at **0.08%**. In raw numbers, this translates to approximately **240,000 American deaths** if no interventions had taken place.

To contextualize this, CDC data from 2019 shows that **167,000 Americans** died from respiratory diseases, including influenza. COVID-19's projected impact represented only a **25% increase** in respiratory-related deaths.

However, CDC data from 2020 and 2021 attributed **767,000 deaths** to COVID-19 following the implementation of an Emergency Use Authorized (EUA) vaccine. These numbers exceeded the projected fatalities significantly, raising critical questions about the efficacy and safety of interventions.

Vaccine Development and Changing Definitions

The COVID-19 vaccines were released under **Emergency Use Authorization (EUA)**, not full FDA approval. To accommodate this, the definition of the term “**vaccine**” was modified to ensure compliance.

Additionally, pharmaceutical companies producing the vaccines were granted **immunity from liability**, protecting them against legal action in cases of injury or death related to vaccine administration.

Key facts surrounding the vaccine development include:

- **Animal testing** of the vaccines was terminated early due to unacceptably high death rates.
- Early **human trials** were also stopped prematurely due to high rates of death and adverse effects.
- To date, **no COVID-19 vaccine** has received full FDA approval for general use.

PCR Testing: Accuracy and Controversies

The Polymerase Chain Reaction (PCR) test, used widely to diagnose COVID-19, has been criticized for its lack of specificity. The test was not originally designed to detect COVID-19 and reportedly had a **false positive rate of 80%**. This is due to the test returning positive results for residual bacteria or viral fragments from infections occurring within the previous **nine months**.

Additional concerns regarding PCR testing include:

- Test swabs were reportedly laced with harmful chemicals, including components similar to those found in vaccines.
- The tests were administered close to the brain's nasal membrane, raising questions about long-term damage.

The Pharmaceutical Industry and Pandemics: A Complex Intersection

The relationship between the pharmaceutical industry and pandemics has become a central point of scrutiny in recent decades, particularly in light of the COVID-19 pandemic and the rapid development of mRNA vaccines. Discoveries and Studies

On August 11, 2024, Japan declared a state of emergency after discovering nanobots in the population of 96 million citizens. A few days later, on August 14, 2024, the World Health Organization (WHO) declared Monkeypox a public health emergency of international concern. Some allegations suggested that the virus had been intentionally introduced through AstraZeneca's vaccine as part of a global control strategy.

The COVID-19 pandemic itself has been marked by similar controversies. Claims surfaced that SARS-CoV-2, the virus responsible for COVID-19, had not been conclusively proven to have originated naturally. Some speculated that the pandemic was engineered to pave the way for the widespread distribution of experimental vaccines, which critics argued contained computer-generated mRNA spike protein sequences and non-biological elements. This has led to accusations of a coordinated effort by pharmaceutical companies, the WHO, and global organizations like the Bill and Melinda Gates Foundation to exploit the pandemic for control over global health systems and to erode civil liberties.

Historical Predictions and Controversies

Looking back at historical predictions about global governance and pandemics, in 1992, John Coleman forecasted the rise of a "post-industrial" world dominated by globalist technocrats, with the goal of reducing the global population by 2050 through wars, epidemics, and starvation. In 2020, the wealth of the top 10 billionaires stood at \$695 billion. By mid-2021, this had more than doubled to \$1.36 trillion, with nine individuals surpassing the \$100 billion mark. This stark increase in wealth raised questions about the financial implications of the pandemic and the role of the pharmaceutical industry in profiting from it.

Reports of problems with vaccine testing, particularly in animal trials, raised early concerns. It was revealed in a 2020 Senate hearing that animal vaccine trials were halted prematurely due to severe adverse reactions, sparking concerns about the safety of these vaccines for human use. This led some to suggest that the public became the test subjects, as these concerns were not fully addressed before vaccine rollout.

The rapid development of COVID-19 vaccines, such as those from Pfizer, Moderna, and Johnson & Johnson, also generated questions about the integrity of the testing processes. The rollout was accompanied by increasing reports of adverse events, including serious conditions such as myocarditis, blood clots, and even deaths. Religious and ethical concerns have also emerged, especially in relation to vaccine mandates and the risks associated with vaccine-induced injuries. Historical and geopolitical contexts suggest that pharmaceutical advancements are deeply intertwined with global power structures, raising concerns about the influence of a "deep state" in shaping global health narratives.

The Unseen Dangers: 5G and Surveillance

Alongside the pandemic, the expansion of 5G technology has raised concerns about its potential role in mass surveillance and population control. While 5G is touted as a technological advancement to enhance internet speeds and connectivity, critics argue that its true purpose could extend beyond this, potentially serving as a tool for mass surveillance and mind control. Some suggest that the frequencies used by 5G networks could influence human emotions and behavior, creating a method for controlling individuals on a mass scale. Coupled with biometric surveillance systems, 5G technology may play a crucial role in the establishment of a global surveillance state, where individuals are monitored and manipulated for political or economic purposes.

The combination of vaccination programs and biometric tracking technologies could serve as part of a broader agenda for totalitarian control. These technologies, when combined with the rapid advancement of AI and surveillance capabilities, suggest a shift toward a more centralized, globalized system of governance. As 5G technology and biometric systems become more prevalent, the potential for human behavior manipulation and the erosion of privacy raises significant ethical and political concerns.

The Emergence of a New World Order?

The concept of a New World Order (NWO) has surfaced in various discussions about the convergence of global health crises, the rise of vaccines, and the introduction of advanced technologies like 5G. Proponents of this theory argue that the pandemic, vaccine mandates, and the expansion of surveillance technologies are deliberate steps toward creating a one-world government. This system, they suggest, would centralize control over finance, health, and surveillance, with global elites exerting control over the masses, while remaining unaffected by these systems.

In this view, the COVID-19 pandemic and the subsequent vaccine rollout were not merely responses to a health crisis but part of a larger agenda. The implementation of 5G, biometric tracking, and global health mandates are seen as tools for shaping a future where populations are controlled through surveillance, genetic modification, and population management. Critics argue that these developments could result in a society where personal freedoms are severely restricted, and human biology is altered to suit the needs of a centralized global authority.

The Controversial Intersection of Medicine and Control

The pharmaceutical industry's growing influence has led to concerns about its role in controlling populations through both medicine and technology. Critics argue that the focus on synthetic drugs and vaccines, rather than natural remedies, has created a system of dependence that benefits pharmaceutical companies at the expense of public health. The rise of digital health systems, biometric monitoring, and the integration of artificial intelligence into healthcare further complicate this issue, with some fearing that these tools could be used not to improve health but to monitor, control, and profit from individuals.

The development of COVID-19 vaccines, especially mRNA-based ones, has faced numerous challenges, including the halting of animal trials due to severe adverse reactions. Critics contend that the public became the test subjects for these vaccines, with safety concerns not fully addressed before mass distribution. Despite the rapid approval process, adverse events such as myocarditis, blood clots, and even deaths have raised significant concerns about the long-term safety and efficacy of these vaccines.

Theories and Alternative Perspectives

Alongside mainstream narratives, numerous alternative theories have emerged, suggesting that the pandemic was orchestrated for financial gain, population control, or as a means to advance technologies like microchips and genetic modification. While these theories remain largely unsubstantiated, they have gained traction in certain circles, fueled by growing distrust in the pharmaceutical industry and government authorities.

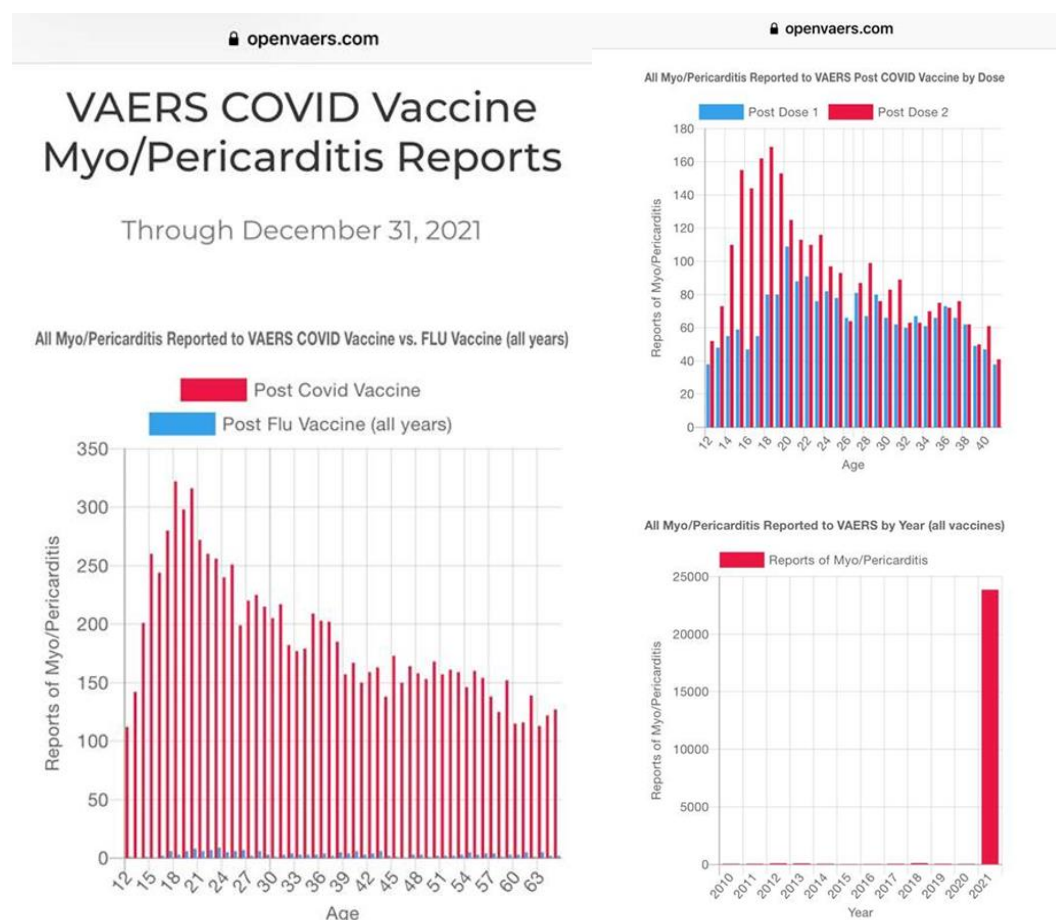

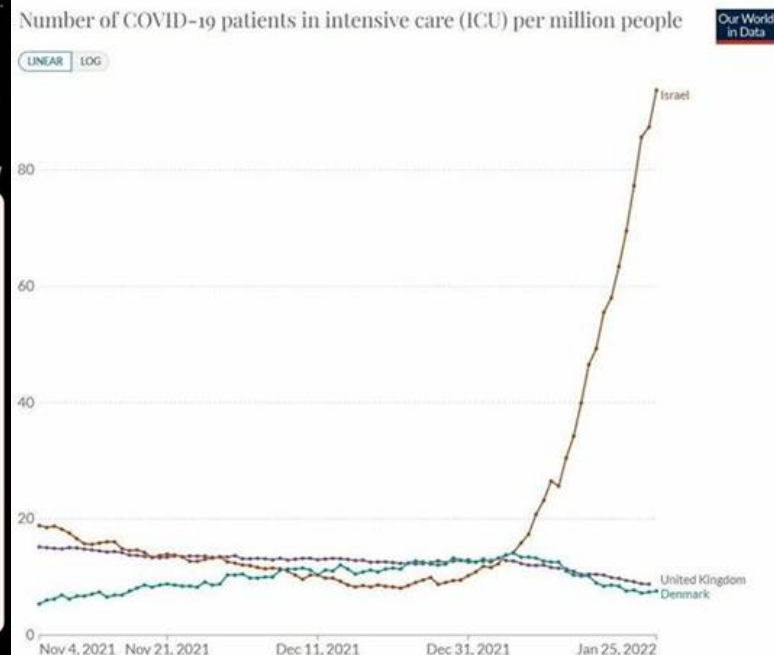
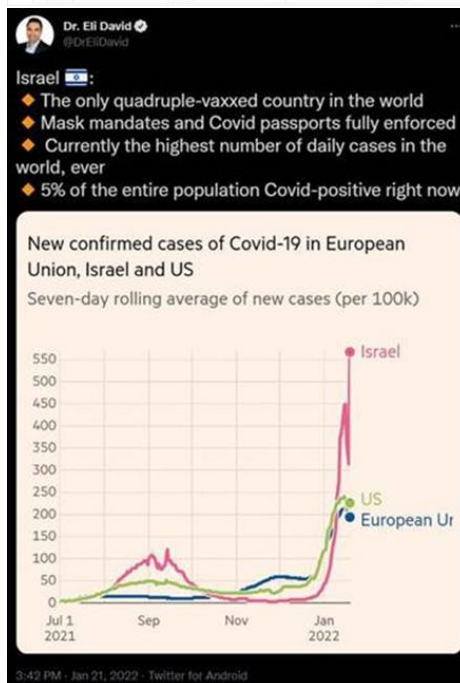
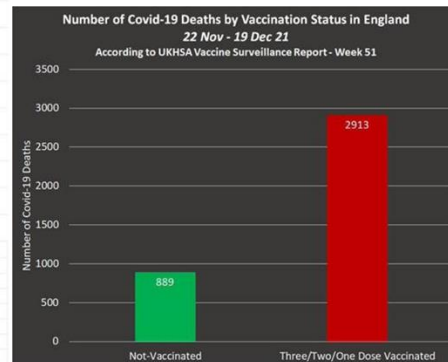
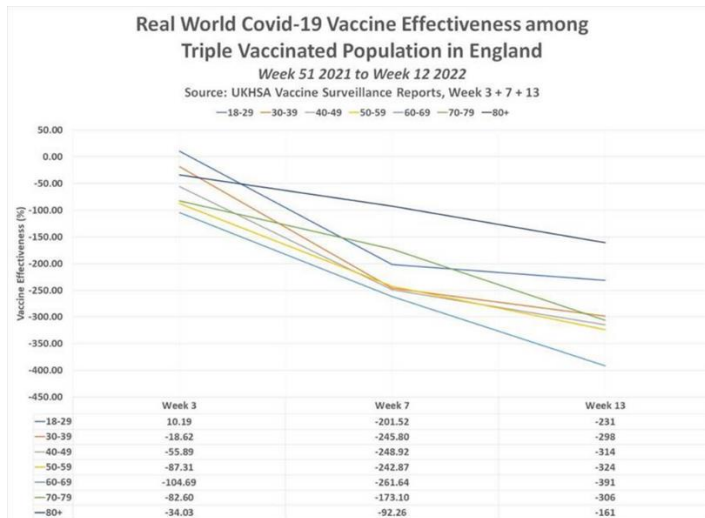
The Road Ahead: Will the Truth Prevail?

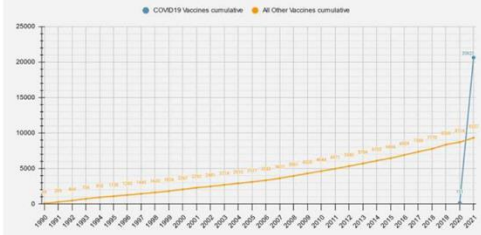

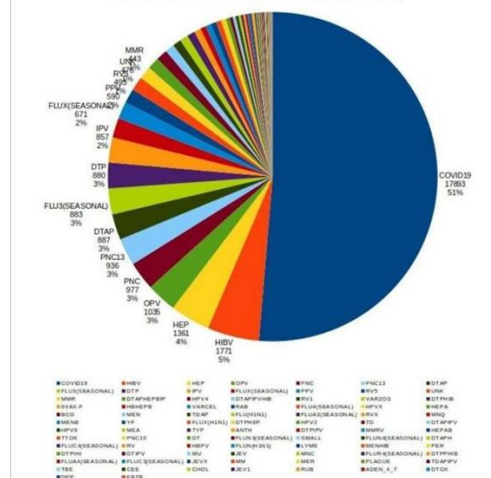

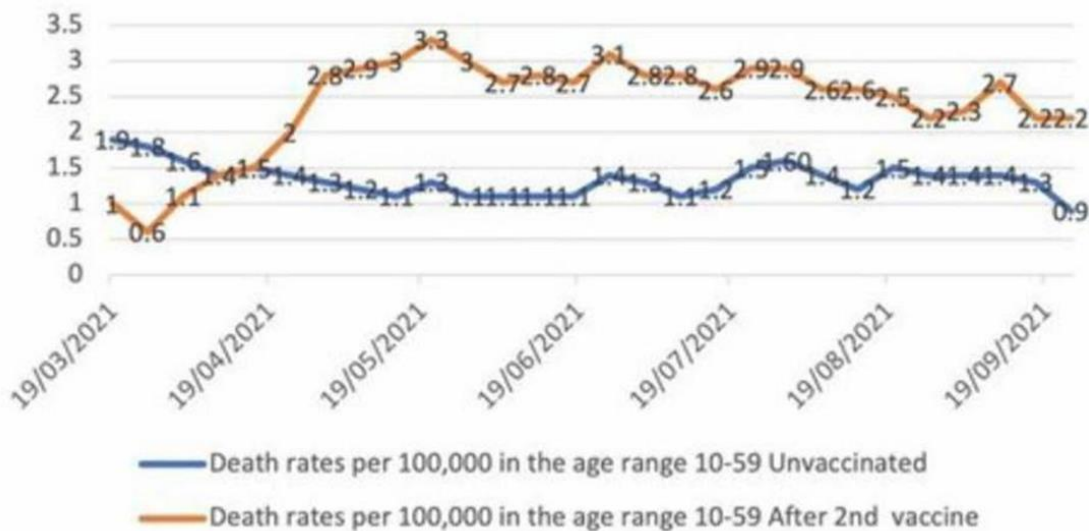
Reported Deaths by Year, COVID19 vs. All Other Vaccines, Cumulatively

VAERS Reported Deaths by Vaccine Type (1988-2021)

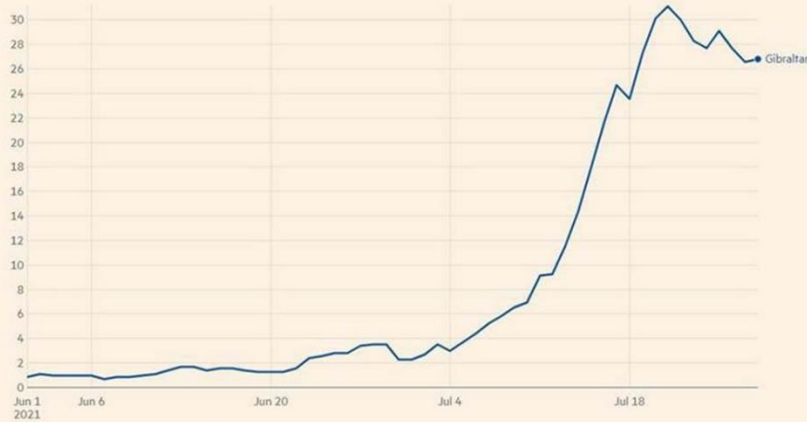

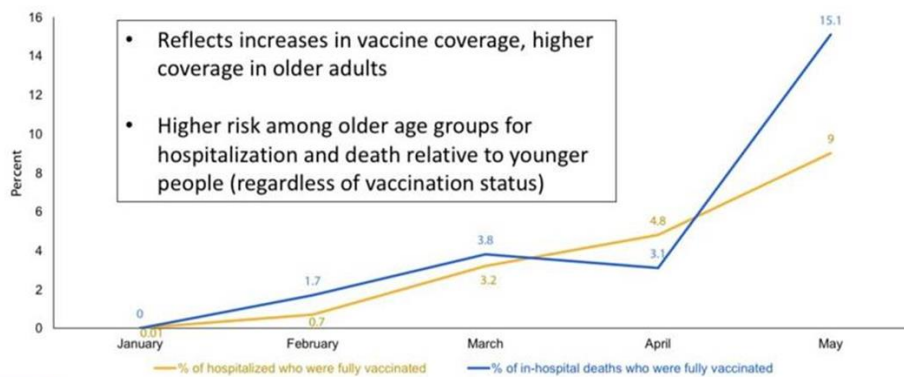
New confirmed cases of Covid-19 in Gibraltar

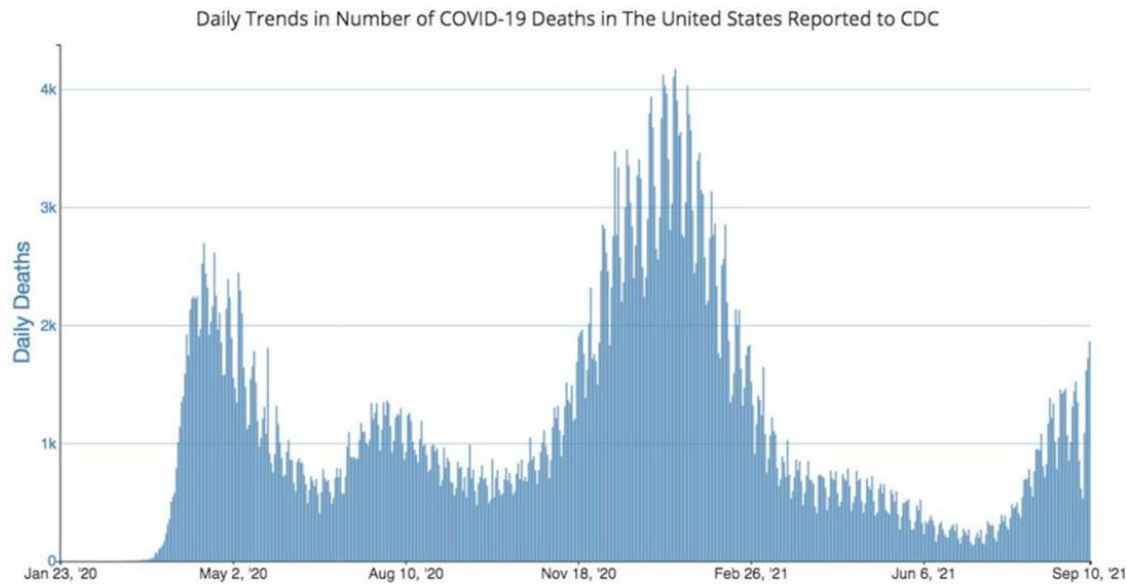

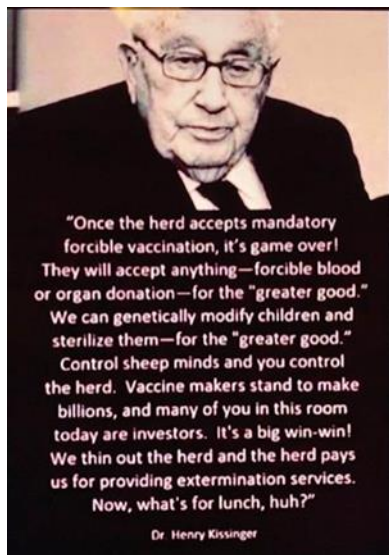

We write to request a transcribed interview of Dr. Anthony Fauci, Director, U.S. National Institute of Allergy and Infectious Diseases (NIAID). Excerpts of emails we are making public today (see enclosed Appendix I) reveal that Dr. Fauci was warned of two things: (1) the potential that COVID-19 leaked from the Wuhan Institute Virology (WIV) and (2) the possibility that the virus was intentionally genetically manipulated. It is imperative we investigate if this information was conveyed to the rest of the government and whether this information would have changed the U.S. response to the pandemic.

Despite Dr. Fauci claiming otherwise on multiple occasions, he was, in fact, aware of the monetary relationship between NIAID, the U.S. National Institutes of Health (NIH), EcoHealth Alliance Inc. (EcoHealth), and the WIV by January 27, 2020.¹ Dr. Fauci also knew that NIAID worked with EcoHealth to craft a grant policy to sidestep the gain-of-function moratorium at the time.² This new policy, designed by EcoHealth and agreed to by NIAID, allowed EcoHealth to complete dangerous experiments on novel bat coronaviruses—with very little oversight—that would have otherwise been blocked by the moratorium.³ In January 2020, Dr. Fauci was also aware that EcoHealth was not in compliance with the terms of its grant that funded the WIV.⁴ EcoHealth was required to submit an annual progress report to NIAID by September 30, 2019, and had not yet done so.⁵ The Committee subsequently learned that EcoHealth failed to submit these reports presumably to hide a gain-of-function experiment conducted on infectious and potentially lethal novel bat coronaviruses.⁶

By January 27, 2020, Dr. Fauci knew NIAID had funded EcoHealth, the WIV was a subcontractor of EcoHealth, and EcoHealth was not in compliance with its grant reporting, in particular a grant that NIAID knew had gain-of-function potential on novel bat coronaviruses. It

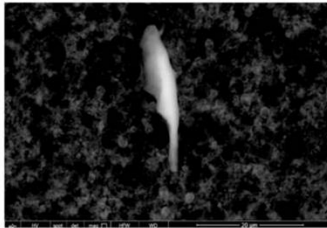

- Providers should keep diligent records of who has been vaccinated, and how many doses of the vaccine have been administered to that person. This is important because individuals who have received one dose of the vaccine will need to have a second dose of the vaccine as it becomes available. Evidence suggests that pregnant people are potentially at increased risk for severe COVID-19-associated illness and death compared to non-pregnant people, underscoring the importance of disease prevention in this population. Given the predominance of women of child-bearing potential among the healthcare workforce, a substantial number of HCP are estimated to be pregnant or breastfeeding at any given time. Currently, there are no data on the safety and efficacy of COVID-19 vaccines in these populations to inform vaccine recommendations. Further considerations around use of COVID-19 vaccines in pregnant or breastfeeding HCP will be provided once data from phase III clinical trials and conditions of FDA Emergency Use Authorization are reviewed.

Post-vaccination symptoms in HCP

Based on available data, COVID-19 vaccination is expected to elicit systemic post-vaccination symptoms, such as fever, headache, and myalgias. While the incidence and timing of post-vaccination symptoms will be further informed by phase III clinical trial data, strategies are needed to mitigate possible HCP absenteeism and resulting personnel shortages due to the occurrence of these symptoms. ACIP recommends staggering delivery of vaccine to HCP in facilities so personnel from a single department or unit are not all vaccinated at the same time. Based on greater reactogenicity observed following the second vaccine dose in phase I/II clinical trials, staggering considerations may be more important following the second dose.^{viii} Because Pennsylvania's approach prioritizes those who are high-risk COVID-19 healthcare personnel, this is expected to stagger initial vaccination somewhat across COVID-19 facing units.

What is the Shielding Approach¹?

The shielding approach aims to reduce the number of severe COVID-19 cases by limiting contact between individuals at higher risk of developing severe disease ("high-risk") and the general population ("low-risk"). High-risk individuals would be temporarily relocated to safe or "green zones" established at the household, neighborhood, camp/sector or community level depending on the context and setting.^{1,2} They would have minimal contact with family members and other low-risk residents.

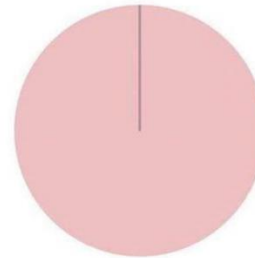

WHO Releases Plan For Global Digital Vaccine Passports Funded By Bill Gates & Rockefeller Foundation

The World Health Organization (WHO) has released a proposal backed by two major globalist organizations that serves as a blueprint for governments to implement a worldwide vaccine passport verification system.

The document, called "Digital Documentation of COVID-19 Certificates: Vaccination Status," funded by none other than the Bill & Melinda Gates Foundation and the Rockefeller Foundation, describes the technical guidance for governments to roll out the program to usher in a global digital ID – in the name of COVID, of course.

"This document lays out an approach for creating a signed digital version of a vaccination record for COVID-19 based on a core data set of key information to be recorded, and an approach for the digital signature. The document leverages existing free and open standards, and is driven by the ethics, use cases and requirements for Digital Documentation of COVID-19 Certificates: Vaccination Status (DDCCVS)."

"This document is therefore software-agnostic and provides a starting point for Member States to design, develop and deploy a DDCCVS solution for national use in whichever format best suits their needs (e.g. a paper card with a one-dimensional [1D] barcode or QR code stickers, or a fully functioning smartphone application developed internationally or locally)."

"The primary target audience of this document is the national authorities tasked with creating or overseeing the development of a digital vaccination certificate solution for COVID-19. The document may also be useful to

government partners such as local businesses, international organizations, non-governmental organizations and trade associations that may be required to support Member States in developing or deploying a DDCCVS solution."

The DDCCVS is meant for use at schools, at work, for international travel, and for contact tracing initiatives.

The document also shows its proposed vaccine passport template, with a QR code featured on the front, but further in the app shows personal information about the number of vaccines received.

What is currently happening with the COVID mandates and protests is nearly identical to what happened 135 years ago with the smallpox vaccine campaigns, where the vaccination made smallpox epidemics worse, the vaccines killed a lot of people, the public refused them and governments responded by harsher and harsher mandatory vaccination laws.

Eventually one of the largest protests of the century broke out in 1885, vaccine mandates were scrapped in one area in favor of alternative management of smallpox, and this is what actually ended smallpox.

Statement on Virus Isolation (SOVI)

Isolation: "The action of isolating; the fact or condition of being isolated or standing alone; separation from other things or persons; solitariness."
—From the Oxford English Dictionary

The controversy over whether the SARS-CoV-2 virus has ever been isolated or purified continues. However, using the above definition, common sense, the laws of logic and the dictates of science, any unbiased person must come to the conclusion that the SARS-CoV-2 virus has *never* been isolated or purified. As a result, no confirmation of the virus' existence can be found. The logical, common sense, and scientific consequences of this fact are:

- the structure and composition of something not shown to exist can't be known, including the presence, structure, and function of any hypothetical spike or other proteins;
- the genetic sequence of something that has never been found can't be known;
- "variants" of something that hasn't been shown to exist can't be known;
- it's impossible to demonstrate that SARS-CoV-2 causes a disease called Covid-19.

In as concise terms as possible, here's the proper way to isolate, characterize and demonstrate a new virus. First, one takes samples (blood, sputum, secretions) from many people (e.g. 500) with symptoms which are unique and specific enough to characterize an illness. Without mixing these samples with ANY tissue or products that also contain genetic material, the virologist macerates, filters and ultracentrifuges i.e. *purifies* the specimen. This common virology technique, done for decades to isolate

bacteriophages¹ and so-called giant viruses in every virology lab, then allows the virologist to demonstrate with electron microscopy thousands of identically sized and shaped particles. These particles are the isolated and purified virus.

These identical particles are then checked for uniformity by physical and/or microscopic techniques. Once the purity is determined, the particles may be further characterized. This would include examining the structure, morphology, and chemical composition of the particles. Next, their genetic makeup is characterized by extracting the genetic material directly from the purified particles and using genetic-sequencing techniques, such as Sanger sequencing, that have also been around for decades. Then one does an analysis to confirm that these uniform particles are exogenous (outside) in origin as a virus is conceptualized to be, and not the normal breakdown products of dead and dying tissues.² (As of May 2020, we know that virologists have no way to determine whether the particles they're seeing are viruses or just normal break-down products of dead and dying tissues.)³

If we have come this far then we have fully isolated, characterized, and genetically sequenced an exogenous virus particle. However, we still have to show it is causally related to a disease. This is carried out by exposing a group of healthy subjects (animals are usually used) to this isolated, purified virus in the manner in which the disease is thought to be transmitted. If the animals get sick with the same disease, as confirmed by clinical and autopsy findings, one has now shown that the virus actually causes a disease. This demonstrates infectivity and transmission of an infectious agent.

None of these steps has even been attempted with the SARS-CoV-2 virus, nor have all these steps been successfully performed for any so-called

pathogenic virus. Our research indicates that a single study showing these steps does not exist in the medical literature.

Instead, since 1954, virologists have taken unpurified samples from a relatively few people, often less than ten, with a similar disease. If No. 1 is correct, and we can't find the virus in the sputum of sick people, then on what evidence do we think the virus is dangerous or even lethal? If No. 2 is correct, then how is the virus spread from person to person? We are told it emerges from the cell to infect others. Then why isn't it possible to find it?

Finally, questioning these virology techniques and conclusions is not some distraction or divisive issue. Shining the light on this truth is essential to stop this terrible fraud that humanity is confronting. For, as we now know, if the virus has never been isolated, sequenced or shown to cause illness, if the virus is imaginary, then why are we wearing masks, social distancing and putting the whole world into prison?

Finally, if pathogenic viruses don't exist, then what is going into those injectable devices erroneously called "vaccines," and what is their purpose? This scientific question is the most urgent and relevant one of our time.

Polio vaccines and the origin of AIDS

Abstract

Although mass vaccination programs have resulted in the eradication of a number of human infectious diseases, vaccine contamination has been a persistent concern. In particular, it is now known that the early polio vaccines were contaminated with at least one monkey virus, SV40. The transfer of monkey viruses to man via contaminated vaccines is particularly relevant to the acquired immunodeficiency syndrome (AIDS), since the causative agent of AIDS, human immunodeficiency virus (HIV), is thought to be derived from a simian precursor virus. Furthermore, human infection with this virus appears to be a relatively recent event. We hypothesize that the AIDS pandemic may have originated with a contaminated polio vaccine that was administered to inhabitants of Equatorial Africa from 1957 to 1959. The mechanism of evolution of HIV from this vaccine remains to be determined.

Smallpox vaccine 'triggered' Aids virus

The Aids epidemic may have been triggered by the mass vaccination campaign which eradicated smallpox.

The World Health Organization, which masterminded the 13-year campaign, introducing new scientific evidence suggesting that immunization with the smallpox vaccine *Vaccinia* awakened the unsuspected, dormant human immunodeficiency virus infection (HIV).

Some experts fear that in obliterating one disease, another disease was transformed from a minor endemic illness of the Third World into the current pandemic.

While doctors now accept that *Vaccinia* can activate other viruses, they are divided about whether it was the main catalyst to the Aids epidemic.

But an adviser to WHO who disclosed the problem, told *The Times*: "I thought it was just a coincidence until we studied the latest findings about the reactions which can be caused by *Vaccinia*. Now I believe the smallpox vaccine theory is the explanation to the explosion of Aids."

Further evidence comes from the Walter Reed Army Medical Centre in Washington. While smallpox vaccine is no longer kept for public health purposes, new recruits to the American Armed services are immunized as a precaution against possible biological warfare. Routine vaccination of a 19-year-old recruit was the trigger for stimulation of dormant HIV virus in him.

This discovery of how people with sub-clinical HIV infection are at risk of rapid development of Aids as a vaccine-induced disease was made by a medical team working with Dr Robert Redfield at Walter Reed.

The recruit who developed Aids after vaccination had been healthy throughout high school. He was given multiple immunizations, followed by his first smallpox vaccination.

Two and a half weeks later he developed fever, headaches, neck stiffness and night sweats. Three weeks later he was admitted to Walter Reed suffering from meningitis and rapidly developed further symptoms of Aids and died after responding for a short time to treatment.

modified versions of the smallpox vaccine to combat other diseases in developing countries.

Other doctors who accept the connection between the anti-smallpox campaign and the Aids epidemic now see answers to questions which had baffled them. How, for instance, the Aids organism, previously regarded by scientists as "weak, slow and vulnerable", began to behave like a type capable of creating a plague.

Many experts are reluctant to support the theory publicly because they believe it would be interpreted unfairly as criticism of WHO.

In addition, they are concerned about the impact on other public health campaigns with vaccines, such as against diphtheria and the continued use of *Vaccinia* in potential Aids research.

The coincidence between the anti-smallpox campaign and the rise of Aids was disclosed privately last year by experts at WHO. The possibility was dismissed on grounds of unsatisfactory evidence.

Advisers to the organization believed then that too much attention was being focused on Aids by the media. It is now felt that doubts would have risen sooner if public health authorities in Africa had more willingly reported infection statistics to WHO.

Instead, some African countries continued to ignore the existence of Aids even after US doctors alerted the world when the infection spread to the United States.

However, as epidemiologists gleaned more information about Aids from reluctant Central African countries, clues began to emerge from the new findings when examined against the wealth of detail known about smallpox as recorded in the *Final Report of the Global Commission of Smallpox Eradication*.

The smallpox vaccine theory would account for the position of each of the seven Central African states which top the league table of most-affected countries; why Brazil became the most afflicted Latin American country; and how Haiti became the route for the spread of Aids to the US.

Smallpox vaccine spread more evenly between males and females in Africa than in the West and why there is less sign of infection among five to 10-year-olds in Central Africa.

Needles were reused 40 to 60 times in the vaccination campaign. Waving the needle across a flame was the main, but perhaps not totally satisfactory method, of sterilisation.

Although no detailed figures are available, WHO information indicated that the Aids league table of Central Africa matches the concentration of vaccinations.

On May 11, 1987, the London Times published an explosive article titled "Smallpox vaccine causes the AIDS virus." It has been suggested that the smallpox vaccination program promoted by WHO is responsible for the spread of AIDS in Africa. Almost 100 million Africans living in Central Africa have been vaccinated by the World Health Organization. The vaccine was blamed for awakening the "dormant" infection of the AIDS virus on the continent. The WHO consultant confessed: "Now I believe that the theory of the smallpox vaccine explains the explosion of (the incidence of) AIDS." Dr. Robert Gallo, one of the discoverers of HIV, told the Times: "The link between the WHO program and the epidemic is an interesting and important hypothesis."

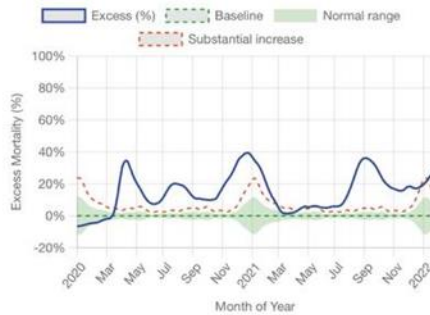

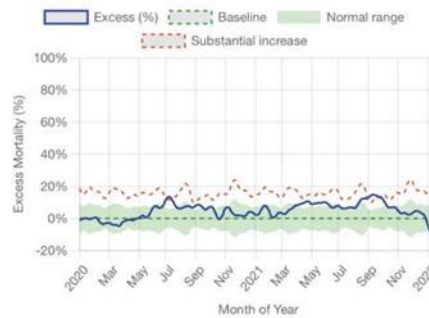

All-Cause Excess Mortality - United States



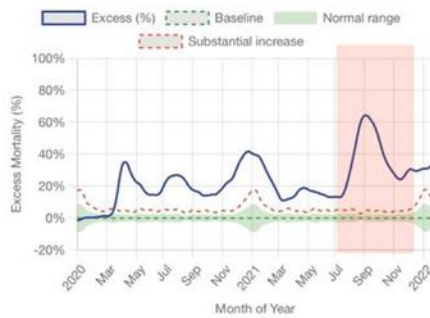
All-Cause Excess Mortality - United States: 0-24 years



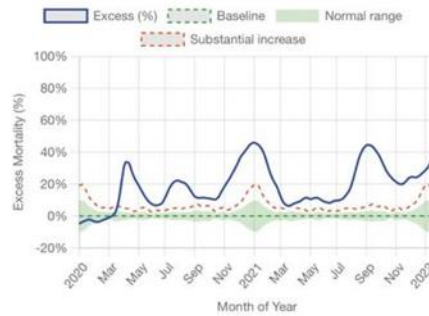
All-Cause Excess Mortality - United States: 25-44 years



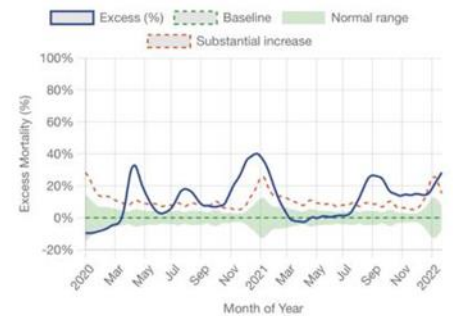
All-Cause Excess Mortality - United States: 45-64 years

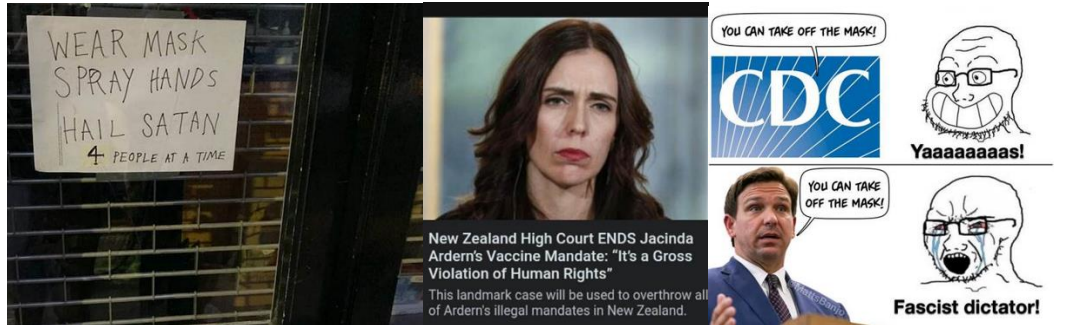

Ignaz Semmelweis Hungarian Physician: 1847

In 1847, Ignaz Semmelweis was working as an assistant professor at Vienna's General Hospital Maternity Clinic. At that time, 10% of the women were dying after giving birth at his hospital, mostly due to infection. The interns at the hospital were routinely performing autopsies and delivering babies without any hand washing in between.

Semmelweis established a new policy of mandatory hand washing, and the mortality rate from infection dropped to one percent.

Rather than receiving praise for his pioneering and life-saving work, the medical community expelled him from the profession. Later, in 1865, his former co-workers tricked him into visiting a mental institution; he was admitted against his will. Semmelweis died mysteriously two weeks later.

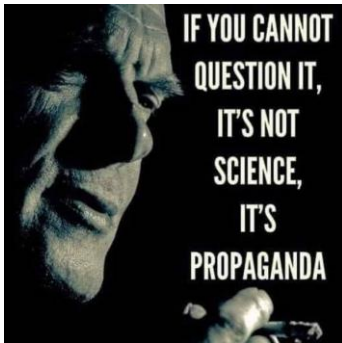

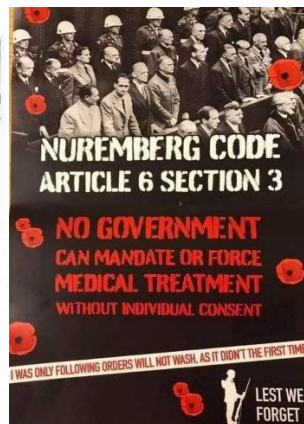

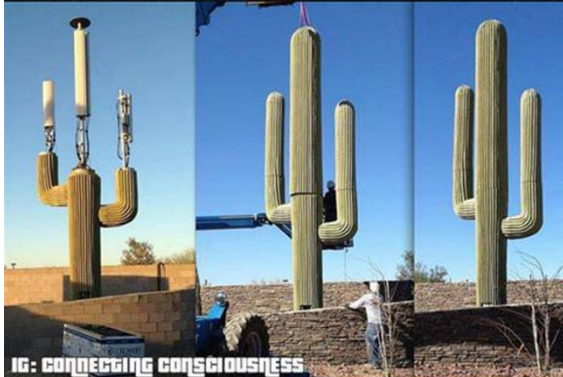
