

# BIBILICAL LAW-INDEX: 1 ENOCH → TORAH → PROPHETS → NEW TESTAMENT

## Purpose:

To demonstrate how God’s Law flows historically from 1 Enoch as it reveals, prefigures, and judicially clarifies laws later codified in Torah, enforced by the Prophets, and ratified and executed in the New Testament.
