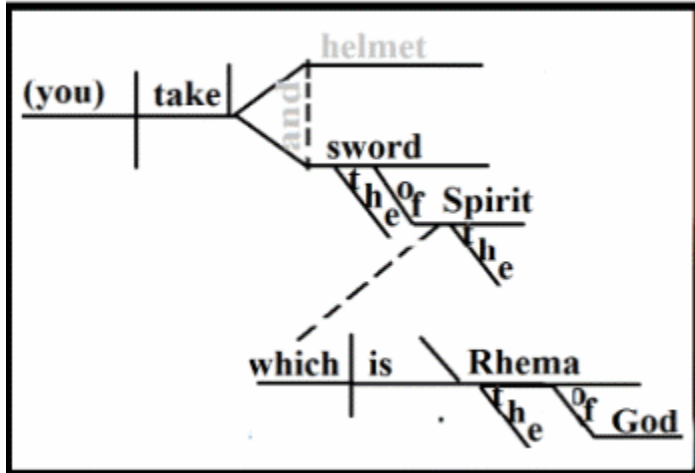
2. Diagram: How the Holy Spirit Turns Logos Into Rhema

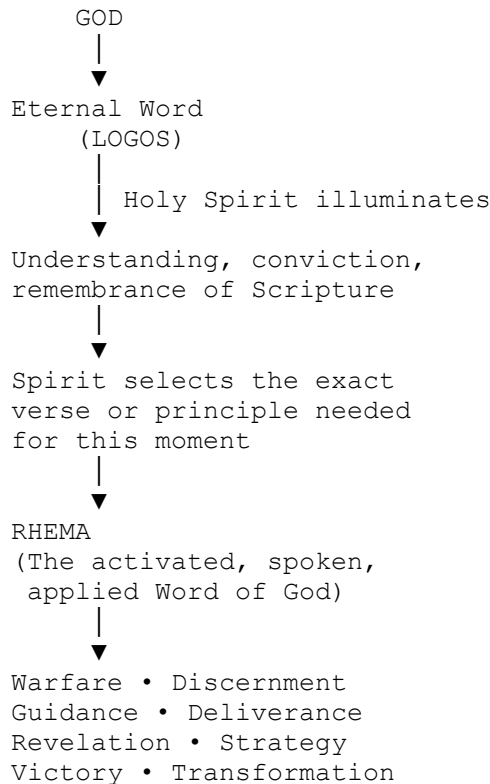
