### Detailed Preliminary Washoe County Assembly Articles

Affirmation,  
First Notice of Existence,  
Bilateral Social Compact Agreement  
by and between the People  
of Washoe County, Nevada state, in  
The United States of America

#### Preamble

We the People, in God We trust, agree that the great and essential principles of rightful liberty and freedom are recognized and established within this Bilateral Social Compact Agreement, the essential rights and rightful liberty for the People within the metes and bounds and seaward boundaries of Washoe County, Nevada State, within The United States of America. The fifty several respective States of the Union are hereby accepted and acknowledged with this Bilateral Social Compact. This Agreement acknowledges that the Constitution for the united States of America, the Law of the Land, guarantees a Republic form of Government for each of the several States in perpetual Union; and

On this \_\_\_\_ day of \_\_\_\_\_ 2025, We the People in our unalienable image, men and women assembled in Washoe County, Nevada State, hereby deny any trespass upon our unalienable image and or rights thereof. We the People have hereby declared our independence and stand on our rights to protect life, rightful liberty, private property, and the *pursuit of happiness*. Our God given natural rights are endowed upon us by our Creator, and no inhabitant, person, government and or People may remove or trespass upon those rights. Our natural rights are superior to any man made orders, statutes, or codes; and

We the People agree that our Lawful Civil Authority is evidenced by the following:

The “Holy Bible,” consisting of the Old and New Testaments, as preserved through the faithful **Hebrew, Aramaic, and Greek manuscript traditions** and accurately rendered in **historically orthodox translations**, as the foundational source of law, morality, justice, and governance;

together with the **historical witness of certain non-canonical writings**, received **not as Scripture**, but as supplemental testimony for instruction, warning, and spiritual discernment—particularly concerning the nature, methods, deceptions, and judgment of Satan, fallen angels, and demonic powers—including:

- **1 Enoch**
- **Jubilees**
- **The Testament of the Twelve Patriarchs**
- **The Wisdom of Solomon**
- **Sirach (Ecclesiasticus)**

all of which are subordinate to, and may neither amend, supersede, nor redefine, the canon of Holy Scripture. (See **Appendix A**)

- The *Mayflower Compact*, circa 1620; and
- The *Law of Nations* or the Principles of Natural Law, by Emmerich de Vattel, circa 1758; and
- The *Declaration of Independence*, circa 1776; and
- *An Ordinance for the Government of the Territory of the United States North-West of the River Nevada* (Northwest Ordinance) circa 1784, as codified in *1 Statute 50* and as implemented by We the People of the *Republic for the united States of America*; and
- The *Constitution for the united States of America*, circa 1787; and
- The Bill of Rights, circa 1791; and
- The *Atlantic Charter*, circa 1941, *Joint declaration by Franklin D. Roosevelt and Winston Churchill*; and **(not sure about this one. FD Roosevelt was deep state.)**
- The “*Declaration of Sovereign Intent of the Republic for the united States of America*,” circa 2010; and
- The “*Proclamation of Claim and Interest of the Republic for the united States of America*,” circa 2012;

as these precedents prove that we do, in fact, have the lawful right to re-inhabit our original constitutional government.

### Section 1: Foundational Principles & Authority of the People

**Article 1: Equal Standing of the People and Source of Authority** We, the People of Washoe County, Nevada, declare that all individuals who enter into this Social Compact stand on equal footing with each other and with the People of all other counties and states in the United States. Each person is endowed by their Creator with unalienable rights, including the rights to life, liberty, the pursuit of happiness, property, and personal reputation. These rights are inherent and cannot be taken away. We affirm that the people are the rightful creators and overseers of county and state governments, which exist to serve—not rule over—the People.

*Intent: To affirm that all authority in government originates from the People equally, and that government exists solely as a servant to the governed. This foundational principle ensures that no public institution, official, or law is ever superior to the rights and will of the People.*

**Article 2: Political Power and the Right to Reform Government** All political power and governmental authority in Washoe County, Nevada, originate from the People. Government is created for the benefit, liberty, and protection of the People, and any government that fails to uphold this purpose becomes illegitimate. The People retain the unalienable right to alter, abolish, or reform government and to hold any public official, agent, or employee accountable for misconduct, corruption, or constitutional violations. Any individual involved in the creation, enactment, or enforcement of unconstitutional laws shall be held personally liable for sevenfold damages to affected individuals, imprisoned for no less than seven years, and permanently banned from holding public office or government employment.

*Intent: To reaffirm the People's supreme authority over government and codify the right to take lawful action against unlawful governance, including holding individuals accountable for violating constitutional or Compact-based protections.*

**Article 3: Freedom of Religion and Moral Accountability** All individuals in Washoe County have the God-given right to worship God, specifically Jesus Christ, or to refrain from worship, according to the dictates of their own conscience. No law shall favor any denomination or religious institution, nor shall any law interfere with the public expression of faith. However, any religious establishment or spiritual practice—whether public or secret—that promotes lies, violence, witchcraft, satanic rituals, or other practices contrary to the teachings of Jesus Christ shall not be protected and may be prosecuted under applicable laws as subversive or terroristic conduct.

*Intent: To protect the natural right to religious freedom while drawing a clear distinction between legitimate worship and criminal or satanic practices disguised as religion. This ensures that protections for religious liberty cannot be exploited by those seeking to undermine society or faith itself.*

#### **Article 4: Supremacy of Yeshua's Law and Protection Against False Religious Authority**

##### **Section 1 – Foundation in Love and Free Will**

This jurisdiction shall be grounded in the love, truth, and authority of Yeshua the Messiah, Son of the Living God. Each person is free to accept or reject Him. Faith must not be coerced, but His teachings serve as the moral foundation for this Compact.

##### **Section 2 – Prohibition of False Religious Influence**

No system of law, ritual, or religious teaching that contradicts the authority and morality of Yeshua the Messiah shall be given legal standing or influence. This includes Sharia, Luciferianism, New Age mysticism, or similar ideologies.

##### **Section 3 – Protection of Believers**

Followers of Yeshua shall be lawfully protected from persecution, censorship, or coercion by individuals or institutions promoting false religious doctrines.

##### **Section 4 – Consequences for Rebellion Against Truth**

While no one shall be compelled to worship Yeshua, those who willfully reject truth and embrace rebellion shall bear its consequences. The righteous shall not suffer for the sins of others.

##### **Section 5 – National Covenant with God**

This County and its governance exist in covenant with God through Yeshua. All public oaths and civic offices shall invoke His authority. No other deity or religious symbol shall be accepted in legal or civic matters.

*Intent: To clearly establish the moral and spiritual foundation of the Washoe County Compact in alignment with the teachings of Yeshua, while maintaining liberty of conscience and opposing counterfeit religious ideologies or legal systems that would usurp God's authority.*

### **Article 5 – Covenant Enforcement**

We, the People, agree that Washoe County covenant enforcement uses equitable remedies, including injunctions, mandamus, habeas corpus, and trusts, via common law courts, under God’s law and common law.

*Intent: This article affirms that enforcement of the covenant shall be rooted in equitable and lawful remedies through common law courts, not arbitrary or bureaucratic fiat. It reflects our belief in fairness, due process, and God’s higher law as the supreme standard of justice.*

### **Article 6 – Dispute Adjudication**

We, the People, agree that all men and women in Washoe County shall have the right to adjudicate disputes through common law courts, ensuring fair and equitable justice, under God’s law and common law.

*Intent: This article guarantees the right of every man and woman to have access to justice in a court aligned with common law and God’s law, free from corporate or statutory manipulation. It affirms judicial independence and the people’s control of their legal system.*

### **Article 7 – Recurrence to Fundamental Principles**

We, the People, agree that our right to assemble and amend this agreement shall never be impeded, must always be protected, and may never be taken away. However, any changes must remain aligned with the Constitution and the original purpose of serving the good of “We the People.” No amendment shall violate national, state, or county oaths.

*Intent: This article reinforces the perpetual right of the People to govern themselves through collective decision-making, while anchoring that power to the timeless values of liberty, justice, and fidelity to constitutional and covenantal oaths.*

### **Article 8 – Proclamation of Claim and Interest**

We, the People, agree that all signatories to this Bilateral Social Compact also affirm and benefit from the “Proclamation of Claim and Interest of the Republic for the united States of America.” Any disputes regarding its interpretation shall be settled by the Common Law Court system of the Republic, which derives its authority from this Compact. All such lawful decisions shall be binding.

*Intent: This article connects the local covenant to the broader structure of the Republic, ensuring lawful consistency and honoring shared foundational claims. It provides a mechanism for peaceful resolution of interpretive questions under a common authority.*

### **Article 9 – Guarding Against Transgressions; Nullification of Conflicting Laws**

We, the People, agree to diligently guard against any transgressions upon our rights and declare that all provisions of this Compact are accepted from the general powers of the People and shall remain permanently inviolate. Any law contrary to this Compact shall be null and void.

*Intent: This article safeguards the sanctity of the Compact by nullifying any legislation that attempts to override its provisions. It reinforces the primacy of the People's will and affirms that their rights shall not be eroded through legislative or judicial overreach.*

### **Article 10 – Rejection of Communism, Marxism, Socialism, and Indoctrination**

We, the People, declare that ideologies or systems repugnant to our constitutional Republic—such as Communism, Marxism, Socialism, and associated indoctrination—are treasonous and forbidden. These systems may only be studied as failed, despotic movements. No person who promotes such systems may hold public trust. Violators shall forfeit government employment, pensions, and benefits. Federally imposed curricula—including but not limited to Common Core, Critical Race Theory, Social Emotional Learning, climate change indoctrination, and transgender agendas—are prohibited in Washoe County schools. Schools shall teach true American history, constitutional principles, entrepreneurship, the Federalist Papers, and the meaning of unalienable rights. Cursive handwriting, music, and art shall be taught in every school.

*Intent: This article rejects all ideological systems that threaten liberty and distort truth. It promotes an education grounded in patriotism, individual liberty, and accurate history, while defending children from harmful or divisive programming.*

### **Article 11 – Clarification of Trust Relationships and Legal Presumptions**

We, the People, declare that no government agency may presume trusteeship or authority over the People without knowing and voluntary consent. Public servants are agents of service, not masters. Legal presumptions of authority shall be rejected unless explicitly accepted by those governed.

*Intent: This article dissolves false presumptions of authority used by bureaucracies to dominate the People. It reasserts the principle that government power must be expressly delegated, never assumed, and that individual sovereignty is supreme unless freely and knowingly contracted away.*

### **Article C1 – Restoration of Article XIII, Ban on Political Parties**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, God's law, and the Constitution for the Republic for the United States of America, do hereby acknowledge, accept, and reaffirm the original intent and mandate of Article XIII of the Constitution—barring any person holding a title of nobility, practicing maritime or admiralty law, or swearing allegiance to any foreign power from running for or holding public office within this County or the Republic.

#### **1. Ban on Titles of Nobility and Foreign Allegiance**

a. No person shall hold public office or serve in any government capacity who:

- Holds or claims any title of nobility,
- Accepts any gift, payment, or honor from a foreign power without the consent of the People,
- Practices or enforces maritime, admiralty, or foreign commercial law over the People,

- Is affiliated with, or owes allegiance to, any foreign government, monarch, international body, or foreign legal jurisdiction.

b. Any person found in violation shall be immediately removed from office, disqualified for life from public service, and subject to prosecution under treason statutes.

2. **Abolition of Political Parties**

a. Political parties, factions, or organized partisan structures are hereby prohibited in the electoral and governance processes of Washoe County and the Republic.

b. All candidates for office shall run and serve as independent representatives of the People, bound only by their oath to God, the Constitution, and the Social Compact.

c. Any attempt to form, operate, or influence governance through political party mechanisms shall be deemed an act of subversion against the Republic.

3. **Ban on Unelected Bureaucratic Rule**

a. No unelected person, foreign agent, or corporate actor shall hold governing authority over the People or administer law without direct lawful appointment and accountability to the County Assembly.

b. Any law, regulation, or mandate issued by an unelected or foreign-controlled body is null, void, and unenforceable within this jurisdiction.

4. **Restoration of Constitutional Intent**

This Article is to be read as a standing reaffirmation of the framers’ intent for a government “of the People, by the People, for the People”—free from foreign influence, corporate usurpation, and partisan corruption.

*Intent: To restore the original constitutional protections of Article XIII, eliminate political party control, and prohibit any governance by foreign or unelected powers—ensuring that all authority in this County and Republic flows directly from God through the People, without interference from corrupt or treasonous systems.*

## **Article 12 – Disbanding BAR Association and Reestablishing Common Law Courts**

We, the People of Washoe County, Nevada, do not recognize the authority of the Nevada BAR Association or any affiliate of it unless its members fully renounce their BAR affiliation and pledge to operate under this Bilateral Social Compact. The BAR is a foreign, unaccountable entity that has corrupted our courts through statutory and maritime law in violation of God’s law and the common law of the land. All judges operating under such systems are hereby dismissed, and our courts shall be returned to lawful common law jurisdiction. All gold-fringed flags and related maritime symbols shall be removed. Additionally, no lobbyist, political party, or special interest group may operate or influence governance within Washoe County. All legal counsel must swear an oath to uphold this Compact and shall be held accountable before a Common Law Grand Jury if they violate that oath. Only counsel adhering to these standards may appear in court. Judicial integrity, transparency, and fidelity to the People shall be enforced through regular audits and grand jury oversight.

*Intent: This article removes corrupt foreign influence from the judicial system and restores true local justice through common law courts, while also banning political party and lobbyist interference.*

## **Article 13 – Term Limits on Elected Offices**

We, the People, agree that all offices held under this Bilateral Social Compact Agreement shall be limited to two terms unless changed by the authority of the Compact.

*Intent: This article enshrines the principle that public service is temporary and accountable, not a career path for entrenched political power.*

## **Article 14 – Public Employee Benefits**

No public servant or government employee in Washoe County, Nevada State, shall receive special emoluments, privileges, or benefits not equally available to the private citizens they serve. All compensation, benefits, retirement plans, and insurance coverage must reflect market-based standards and mirror those available to the general workforce. Public employment shall not be treated as a protected or elite status. There shall be:

- No taxpayer-funded pensions or early retirements.
- No lifetime appointments or job protections beyond merit-based performance.
- No unions or collective bargaining agreements that impose fiscal burdens on the People.
- No self-approved pay raises or benefit increases.
- No taxpayer-funded healthcare or retirement plans beyond what is available to private sector workers.
- Mandatory contributions to Social Security, private insurance, and retirement accounts in the same manner as private citizens.

All elected and appointed officials must be subject to the same rules, taxes, costs, and limitations as the People. Public office is a temporary position of service, not a career of privilege. Respect must be earned through accountability and integrity, not inherited, assumed, or entrenched.

*Intent: This article ensures that public service remains a position of duty and stewardship—not entitlement or personal gain. It prevents the rise of a political or bureaucratic class insulated*

*from the consequences of the policies they impose on others. Inspired by the Virginia Constitution's original safeguards, it restores fairness, fiscal sanity, and humility to public employment, ensuring that public workers live by the same rules, responsibilities, and limitations as the People they serve.*

#### **Article 15 – Creation and Authority of the Washoe County Assembly**

We, the People, hereby establish the Washoe County Assembly as the lawful representative body of those who sign this Bilateral Social Compact Agreement. This Assembly shall have the power to draft amendments to this Compact and initiate constitutional reform at the state level, always upholding the principles of local sovereignty, transparency, and public accountability under God's law and common law.

*Intent: This article creates a legitimate local governing body grounded in the will of the People and empowered to make necessary constitutional reforms.*

#### **Article 16 – Preservation of the Covenant through Assembly and Amendments**

We, the People, affirm that all men and women in Washoe County who have signed this Compact are bound by its protections and responsibilities. Through regular assemblies and lawful amendment processes, we shall preserve the liberties granted by this covenant, in accordance with God's law and common law.

*Intent: This article guarantees that the covenant will evolve as needed while protecting the foundational liberties and principles enshrined within it.*

#### **Article 17 – Alignment with Republic Principles and Judicial Interpretation**

We, the People, agree that the continued enforcement and interpretation of this Compact shall remain aligned with the founding principles of the Republic. Any disputes arising from or within this Compact shall be settled through common law courts under the authority of God's law and the Constitution.

*Intent: This article ensures continuity with the values of the original American Republic and empowers common law courts to serve as the final interpreters of the covenant's meaning and application.*

#### **Article 18 – Non-Negotiable Foundational Principles**

We, the People, understand and commit to the following NON-NEGOTIABLE Principles:

- a. County Courts shall operate in accordance with the Law of Nations by Emerich de Vattel (1758), as referenced in Attachment 1 and the Preamble of this Compact and future ratified State Constitution.
- b. All Judges and Justices must take an oath and be bound to the authority of this Compact. Judges shall interpret, not legislate.

c. The right to bear arms in defense shall remain unimpeded within Washoe County, Nevada State, ensuring a lawful Constitutional Republic.

d. Any action by government agencies or NGOs exceeding the bounds of this Compact or due process—including actions by health departments, police, military, mayors, or the Nevada Revised Code—is forbidden.

e. All fraud against the People of the Republic of the United States of America is treason.

f. All unsolicited sales, calls, texts, or emails are criminal. Each instance shall carry a fine of \$100,000 plus punitive damages and a one-year prison term. Repeat offenders shall forfeit all assets and be imprisoned for life, regardless of Do Not Call registration.

*Intent: This article enshrines absolute principles for judicial conduct, armed self-defense, anti-fraud enforcement, and protection from governmental or corporate abuse. It sets irrevocable boundaries to preserve liberty and uphold truth.*

#### **Article 19 – Prohibition of Federal Agencies Without Consent**

Neither FEMA nor any other Federal Agency shall enter or assert jurisdiction in Washoe County, Nevada State, without explicit approval from the Governor following a vote by the Washoe County Assembly. Even then, they shall remain subordinate to local authorities.

*Intent: This article protects local sovereignty by restricting outside federal intervention unless explicitly authorized, reinforcing community-led emergency management.*

#### **Article 20 – Violation of Oath as Sedition**

Violation of an oath of office shall be considered sedition against the Constitution or applicable State Constitution, subject to full legal penalties following due process.

*Intent: This article imposes strict accountability for public servants who betray their constitutional oaths, treating such betrayal as an attack on lawful governance.*

#### **Article 21 – Nullification of Nevada Revised Statutes in Washoe County**

All Nevada Revised Statutes (NRSs) are hereby null and void within Washoe County, Nevada State. Additionally, lobbyists and political parties are declared unlawful within the county.

*Intent: This article asserts full local self-governance by rejecting state-imposed statutes and banning external political manipulation.*

#### **Article 22 – Judicial Selection, Oversight, and Accountability**

The judicial branch shall serve the People as a function of community trust, integrity, and fairness. No judicial position shall be held as a lifetime appointment. All judicial offices shall be filled through a merit-based selection process and shall be considered positions of public service rather than privilege or authority. Two 6-year term maximums at any level.

### Section 1 – Selection and Appointment Process

- All judicial appointments shall follow constitutional procedure: the President shall nominate candidates, and the Senate shall confirm them, without influence from any political party, lobbying group, government agency, or foreign entity—including but not limited to the Federalist Society.
- Judicial candidates must be experts in Common Law or the Law of the Land, with a verifiable record of impartial rulings, respect for due process, and fidelity to natural rights.
- County judges shall be vetted and selected by their respective County Assemblies.
- Judges serving in higher state courts shall be selected from the pool of County judges by the Governor and confirmed by the Senate.

### Section 2 – Eligibility and Restrictions

- Candidates may be attorneys licensed under the American Bar Association provided they have publicly resigned and renounced any foreign titles of nobility, allegiance, or oath that supersedes their constitutional obligations.
- No judge or candidate may belong to or be affiliated with any corporation, business, secret society, fraternal or foreign order, or organization with loyalties outside the jurisdiction of the People they serve. They must not be biased or purchasable.

### Section 3 – Term, Review, and Oversight

- All judicial appointments shall be for fixed terms, subject to annual performance reviews by a panel of peers and members of the People’s Assembly.
- All judges shall be subject to annual, independent financial audits. Any undeclared gifts, lobbying payments, or conflicts of interest shall be grounds for immediate investigation and removal.

### Section 4 – Accountability and Penalties

- Any proven act of judicial bias, corruption, conflict of interest, or malicious disregard for due process shall result in immediate suspension, public review, and, upon confirmation, disqualification and potential criminal prosecution.
- The People retain the right to recall any judge through lawful petition and hearing by the Assembly.

### Section 5 – Oath and Service to the People

- Judges shall take an oath to uphold the Constitution, Common Law, and the rights of the People. Their loyalty shall be solely to the People and the principles of justice, liberty, and truth.
- Judicial service is a civic duty. No judge shall be immune from prosecution for misconduct, and all proceedings concerning their discipline shall be public.

*Intent: This article ensures judicial offices are filled by principled, accountable individuals dedicated to serving the People. It eliminates elitism, lifetime appointments, and foreign or political influence while requiring continual oversight and transparency in order to restore justice, fairness, and integrity to the courts.*

## **Article 23 – Law Enforcement and Emergency Services Selection, Oversight, and Integrity Standards**

### Section 1 – Community-Centered Leadership Selection

All department heads for police, fire, and sheriff's departments shall be selected through a transparent, merit-based process initiated by the County Assembly. Qualified candidates shall be:

- Nominated by the County Assembly
- Vetted and shortlisted by independent citizen review panels
- Appointed by the Governor
- Confirmed by the Senate

This process shall be free from influence by political parties, unions, federal agencies, corporate lobbies, woke officials and their woke policies.

### Section 2 – Qualifications and Vetting

All department leaders and officers must:

- Demonstrate a deep knowledge of constitutional law, natural rights, and the Common Law tradition
- Have a record of integrity, fairness, and bias-free service
- Pass rigorous psychological, ethical, physical, and skills-based evaluations
- Be free of criminal history, known affiliations with corrupt organizations, or undisclosed financial entanglements
- Submit to a full background investigation and lie detector test prior to appointment

### Section 3 – County Oversight and Accountability

- County Assemblies shall maintain ongoing authority to audit, investigate, and discipline all police, fire, and sheriff's personnel
- All complaints from the public must be reviewed within 30 days by a standing Civil Accountability Board
- Officers or leaders found guilty of misconduct, abuse of power, fraud, or civil rights violations shall face immediate removal, full legal prosecution, and personal liability for damages

### Section 4 – Regular Reviews and Transparency Requirements

- All department heads shall be subject to annual performance reviews and financial audits
- Review panels shall include civilian representation selected by lot from the County Assembly roll
- Annual reports detailing performance, incidents, complaints, and expenditures shall be made available to the public in plain language

### Section 5 – No Lifetime Appointments or Entitlements

- No police, fire, or sheriff personnel shall receive guaranteed positions, tenure, or pension entitlements as a matter of course
- Service in these departments is considered a duty of community trust, not a career of political leverage or privilege
- Term limits, rotation of leadership, and recurring re-qualification shall be mandatory

### Section 6 – Prohibition of Militarization and Federal Interference

- All police and sheriff operations shall remain under local, civilian control
- The use of military-grade weapons, surveillance technologies, or federal resources must be expressly approved by the County Assembly for limited, defined purposes only

- Any cooperation with federal or international agencies shall require full public disclosure and pre-approval by the Assembly

#### Section 7 – Oath and Service to the People

- All law enforcement and emergency service workers shall take an oath to uphold the Constitution, Common Law, and the rights of the People. Their loyalty shall be solely to the People and the principles of justice, liberty, and truth.
- Law enforcement and emergency service is a civic duty. No employee shall be immune from prosecution for misconduct, and all proceedings concerning their discipline shall be public.

*Intent: This article ensures that law enforcement and emergency services operate with integrity, accountability, and full transparency. It prohibits corruption, federal interference, and abuse of power, restoring control to the local community while upholding constitutional principles and the People’s natural rights.*

### 3. Voting Integrity

- Article 24 – Same-day, in-person, paper ballot voting with valid ID
- Article 25 – Restricts mail-in ballots
- Article 26 – Washoe County Boundaries

#### Article 24 – Lawful Voting Standards

We, the People, agree that same-day, paper ballot, in-person voting by lawful voters not on any form of public assistance—with the exception of Social Security or Medicare, which they or a parent paid for—shall be the only lawful mechanism for elections concerning Washoe County Government. Only citizens presenting valid, lawful identification may vote. The use of any fraudulent voting machines is prohibited and shall not be recognized as a lawful expression of the People’s will. Violations shall be subject to lawful punishment.

*Intent: This article establishes secure, transparent, and in-person voting as the only acceptable method for lawful elections in Washoe County, ensuring integrity, accuracy, and citizen accountability.*

#### Article 25 – Mail-In Ballot Safeguards and Penalties for Fraud

We, the People, agree that mail-in ballots shall only be lawful if accompanied by a thumbprint adjacent to the voter’s signature. If credible evidence of fraud arises, a hand-counted, door-to-door audit shall be conducted. If fraud is confirmed, the guilty party shall be liable for all costs and subject to criminal prosecution, including life imprisonment without parole and hard labor. The risk of fraud shall take precedence over convenience, even for immobile voters.

*Intent: This article places strict conditions and harsh penalties on mail-in voting to protect election integrity and deter tampering or fraud that could undermine the People’s voice.*

#### Article 26 – Washoe County Boundaries

We, the People, agree that Washoe County’s established boundary lines are non-negotiable and shall be upheld by men and women under God’s law and common law.

*Intent: This article affirms the sovereignty and territorial integrity of Washoe County, ensuring that its defined geographic boundaries remain inviolable and protected under law.*

## **4. Foreign Influence / Agencies**

- Article 27 – Ban on CIA and FBI
- Article 28 – Ban on unelected bureaucracies (e.g. FED, CDC, WHO, WEF, NGOs)
- **Article B1 – Sole Allegiance Citizenship Clause**

### **Article 27 – CIA and FBI Limits and Controls**

We, the People, agree that the CIA, FBI, or any other federal law enforcement organizations may operate in Washoe County, Nevada State, only after receiving written approval from the Washoe County Assembly and under the direct supervision of local law enforcement with active oversight by the Assembly. No exceptions shall be permitted. Daily briefings must be provided to both local law enforcement and the County Assembly.

*Intent: This article ensures that federal agencies cannot act independently within Washoe County and must be held accountable to local authority and the People’s Assembly, thereby safeguarding local sovereignty.*

### **Article 28 – Ban on Unelected Bureaucracies**

We, the People, agree that no unelected bureaucrat, agency, or foreign body shall have any lawful authority or influence over the People of Washoe County, Nevada State. This includes, but is not limited to, the Centers for Disease Control and Prevention (CDC), World Health Organization (WHO), World Economic Forum (WEF), and Non-Governmental Organizations (NGOs). These entities are declared unconstitutional, unlawful, and hostile to the People’s sovereignty. All current, former, or future members of such entities shall be deemed guilty of treason and subject to arrest, trial, and justice without delay.

*Intent: This article rejects unlawful and foreign interference in local governance and classifies globalist or unelected organizations as threats to liberty and local constitutional order.*

### **Article B1 – Sole Allegiance Citizenship Clause**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, and in covenant with the one true God, do declare that all citizens within the jurisdiction of this Compact must hold exclusive allegiance to the Republic for the United States of America and to the Kingdom of God under the Lordship of Jesus Christ (Yeshua the Messiah). Dual citizenship—whether civil or spiritual—is hereby outlawed as incompatible with true sovereignty, lawful order, and divine covenant.

#### **1. Ban on Dual Civil Citizenship and Conflicting Allegiances**

- a. No individual shall hold citizenship, allegiance, or sworn loyalty to both the Republic for the United States of America and any foreign nation, kingdom, or global entity— including, but not limited to:
  - The modern state of Israel,

- The United Nations,
- The European Union,
- The Vatican,
- Any globalist, corporate, or dual-sovereignty compact.

b. All residents, officers, and candidates for public office must renounce all foreign citizenships and loyalties in word and deed as a precondition to lawful participation in governance or public service under this Compact.

## 2. **Prohibition of Spiritual Dual Allegiance**

a. No individual may simultaneously claim to be a follower of Jesus Christ while knowingly serving, endorsing, or participating in:

- Satanic, Luciferian, occult, or New Age practices,
- Secret societies, false religions, or “interfaith” doctrines that deny Christ's exclusivity,
- Government, corporate, or ideological systems that oppose God's law or promote moral relativism.

b. The Word of God declares: “*No man can serve two masters.*” Spiritual allegiance is exclusive, and compromise is treason to the Kingdom of Heaven.

## 3. **Declaration of Sole Citizenship Requirement**

All lawful citizens under this Compact must publicly and lawfully affirm:

- Sole allegiance to the Republic and its Constitution,
- Sole spiritual citizenship in the Kingdom of God under Christ,
- Their rejection of any conflicting nationality, ideology, or false spiritual authority.

Failure to affirm such allegiance—or to continue in double-minded participation—shall be grounds for:

- Disqualification from citizenship privileges,
- Removal from office or fiduciary duty,
- Judicial review by the Assembly and People’s Grand Jury.

## 4. **Enforcement and Public Integrity Safeguards**

a. Any person discovered to be secretly maintaining dual citizenship, oaths, or foreign loyalties in violation of this Article shall be subject to:

- Immediate exposure and public review,
- Permanent ineligibility for public office or vote,
- Loss of citizenship rights and lawful removal from the territory if deemed subversive.

b. This Article does not prohibit peaceful visitation, cultural interaction, or mission work across national borders, provided no oath, obligation, or allegiance to a foreign sovereign or spiritual authority is pledged or accepted.

*Intent: To preserve the purity of allegiance—both national and spiritual—within Washoe County and the Republic, acknowledging that no man can serve two masters, and that our God is a jealous God who demands our full loyalty. Divided loyalty breeds treason, deception, and disorder; this Article ensures the People remain one in purpose, one in faith, and one under rightful law.*

- Article 42 – Presentment/indictment required for charges
- Article 43 – No corruption of blood or forfeiture of estate

- Article 49 – Right of Jury Nullification in Defense of Liberty
- Article 50 – Authority of Grand Juries to Revoke Harmful Corporate Charters

### **Article 29 – Free and Equal Elections**

We, the People, agree that all elections shall be free and equal within each body politic in Washoe County under the jurisdiction of the Washoe County Assembly, formed under and derived from this Bilateral Social Compact Agreement. No property qualification shall be required for eligibility to hold office or to exercise the right to vote within Washoe County, Nevada State, a State of the Union within the Republic for the united States of America.

*Intent: This article ensures that all lawful residents of Washoe County have equal access to voting and eligibility for office, without arbitrary property requirements or unequal treatment.*

### **Article 30 – Freedom of Speech, Press, and Protection Against Propaganda**

We, the People of Washoe County, reaffirm our sacred right to speak, write, and publish freely on all matters. This right belongs to each sovereign individual and shall not be infringed, restricted, or licensed by any government, corporation, foreign power, or agent thereof. However, the deliberate use of speech or media to defraud, manipulate, incite violence, or psychologically harm others shall be subject to lawful remedy. No protections shall be extended to organizations or media outlets that knowingly spread lies, propaganda, or coercive narratives for political, financial, or ideological gain. The press must remain free—but never corrupt. All media operating within the county shall be held to standards of honesty, transparency, and public accountability. Violators may be publicly investigated, fined, or banned from broadcasting if found to act in bad faith or outside the bounds of truth.

*Intent: This article safeguards the natural right to free speech and press, while also providing lawful means to address intentional misinformation, manipulation, or psychological harm by bad actors or corrupt media.*

### **Article 31 – Right to Trial by Jury and Corporate Accountability**

We, the People, agree that the right to a trial by a jury of one's peers—under constitutional and common law—shall always be protected and can never be taken away or altered by any outside authority. All jury trials must take place in the same local area (jurisdiction and venue) where the issue occurred. This right applies equally to everyone, regardless of district or form of governance. Furthermore, no corporation, business entity, or its officers shall be shielded from personal responsibility for wrongdoing by so-called "corporate protections" or "limited liability" clauses. All individuals acting on behalf of any corporation will be held personally accountable for harm or fraud they commit. The rights of the People shall not be undermined by corporate wealth, status, or influence.

*Intent: This article guarantees the local and impartial administration of justice through jury trials and prevents corporations from escaping responsibility through legal loopholes or protections not afforded to individual citizens.*

### **Article 32 – Protection Against Unreasonable Search and Seizure**

We, the People, agree that all inhabitants and People of Washoe County shall be secure in their persons, homes, papers (including digital and electronic records), possessions, and property against any and all unlawful or unreasonable searches and seizures. No government agent, agency, or private contractor acting on behalf of any authority shall infringe upon this right under any circumstances, including in the name of national security, public safety, or emergency declarations.

A valid search or seizure may only be conducted with a lawfully obtained warrant bearing the wet-ink signature of a Common Law Judge or Justice, issued upon sworn affidavit of harm or crime committed, supported by physical evidence, and filed under penalty of perjury in the proper court of venue. All warrants must specifically describe the person, place, or property to be searched or seized, and must be presented upon demand before any such action may lawfully occur.

This article expressly prohibits blanket, warrantless searches such as those routinely conducted at airports, transportation hubs, or public venues, which were unlawfully instituted under the guise of national security following the events of September 11, 2001. Such practices constitute unconstitutional government overreach and are null, void, and unenforceable under this Bilateral Social Compact Agreement.

Any individual—government official, law enforcement officer, corporate contractor, or other agent—who authorizes, orders, or participates in such unlawful searches or seizures shall be held personally and criminally liable, regardless of rank, title, or command structure. Sovereign immunity, qualified immunity, or corporate protections shall not apply in such cases. Violators shall face prosecution under Common Law and Natural Law and be held to account for any harm done to the People.

*Intent: This article provides strict safeguards against unauthorized government intrusion and reestablishes the rule of law in all cases of personal privacy, property, and constitutional rights. It directly addresses and eliminates post-9/11 abuses and establishes personal accountability for all violators.*

### **Article 33 – Protection from Deprivation of Rights Without Law**

We, the People, agree that no inhabitant, person, or any of the People—regardless of status—shall be taken, imprisoned, or deprived of freehold, rightful liberties, outlawed, exiled, or in any manner destroyed or deprived of life, liberty, property, or reputation, except by law written within the State’s statutes as derived from this Bilateral Social Compact Agreement.

*Intent: This article affirms that no one may be deprived of their natural rights, liberty, or property without full adherence to lawful due process as established by the People through this Compact.*

### **Article 34 – Government Accountability for Injury**

We, the People, agree that government and each government official involved in unlawful activity shall be personally and individually accountable for any injury incurred to inhabitants, persons, People, property, goods, or reputation. All shall have remedy by due process of law; and right and justice shall be administered without sale, denial, or delay.

*Intent: This article guarantees the personal accountability of government agents for all harm caused and ensures full access to timely and impartial justice through due process.*

### **Article 35 – Habeas Corpus and Bail Protections**

We, the People, agree that all accused shall be bail-able, where the proof is evident, or the presumption is strong. The privilege of habeas corpus shall not be suspended, unless in cases of rebellion or invasion when public safety may require it, as decided by the authority derived from this Bilateral Social Compact Agreement and Washoe County, Nevada State, respectively.

*Intent: This article guarantees the right to habeas corpus and fair bail practices, affirming that detention without lawful cause is prohibited except in extreme emergencies requiring public protection.*

### **Article 36 – Rights of the Accused in Criminal Prosecutions**

We, the People, agree that in all criminal prosecutions, every accused individual shall be guaranteed the following rights, without exception:

1. **Right to Representation of Choice:** The accused has the right to defend themselves personally or with the assistance of a representative of their choosing. No association with any foreign bar or private guild (e.g., American BAR Association) shall be required as a condition for lawful representation.
2. **Right to Know the Charges:** The accused has the immediate right to receive a clear written notice of the nature and cause of the accusation within 48 hours of arrest or detainment.
3. **Right to Confrontation:** The accused has the right to face and question any witnesses making accusations against them, including the right to examine any affidavit of harm submitted under oath. No anonymous testimony shall be used in lieu of sworn, accountable statements.
4. **Right to Obtain Witnesses and Evidence in Defense:** The accused shall have full due process rights to subpoena and obtain witnesses, evidence, and documentation in their favor, without obstruction.
5. **Right to a Speedy and Public Trial:** All trials must commence within 30 days of indictment unless the accused requests a delay. Any delay beyond this time, not requested by the accused, shall be considered a denial of due process and grounds for dismissal of charges, unless justified by clear, documented necessity approved by a neutral judicial authority.
6. **Penalty for Unjust Delays:** Any judge, prosecutor, or officer found intentionally causing delay, suppressing evidence, or denying due process shall be subject to removal from office, loss of all public trust, and civil or criminal liability, including financial restitution to the accused.
7. **Right to an Impartial Jury:** The accused shall be tried by an impartial jury of twelve peers residing within the county or lawful venue where the alleged crime took place. Jurors must be free of bias or external influence, and selected randomly from among the People.
8. **Right to Remain Silent:** No person shall be compelled to testify or provide evidence against themselves under any circumstances. Refusal to testify shall not be used as evidence of guilt.
9. **Authority and Legal Framework:** All criminal proceedings shall be conducted by courts lawfully established under this Bilateral Social Compact Agreement, operating under Common Law and in harmony with the Law of Nations, as written by Emer de Vattel (1758), as cited in Attachment 1.

*Intent: This article establishes the full spectrum of constitutional and common law protections for individuals accused of crimes, ensuring fair and impartial legal processes, and preventing abuse of prosecutorial power.*

### **Article 37 – No Excessive Bail, Fines, or Cruel Punishment**

We, the People, agree that excessive bail shall in no case be required; nor shall excessive fines be imposed; nor shall cruel or unusual punishments be inflicted. No redemption of the Bond shall be

required unless actual damage or injury has been proven in fact. A 7x restitution requirement and eye-for-eye punishments will apply to all such cases.

*Intent: This article reinforces the prohibition of excessive and unjust punishment while emphasizing proportionate restitution and individual accountability for provable harm.*

### **Article 38 – Protection Against Double Jeopardy**

We, the People, agree that no inhabitant, person, or any of the People shall, for the same offense, be twice put in jeopardy of dissolution or accusation, unless the same offense is committed again or in cases of fraud, witness tampering, or other improper verdict influences that are uncovered and proven. There are no statutes of limitations in cases where fraud, witness tampering, or other improper verdict influences are proven, and all fines and penalties shall be multiplied by seven (7).

*Intent: This article protects individuals from being retried for the same offense while allowing justice to prevail in cases of proven fraud or manipulation, ensuring severe consequences for such abuses.*

### **Article 39 – Just Compensation for Private Property**

We, the People, agree that private property shall not be taken or applied to public use without the consent of the property owner, and without just compensation to be offered and accepted.

*Intent: This article ensures the sacred right of property ownership, requiring fair compensation and voluntary consent for any public use.*

### **Article 40 – Truth as a Defense in Indictments**

We, the People, agree that in all criminal indictments, the accused shall have the right to present the truth as evidence in their defense.

If the Grand Jury finds that:

- the evidence is true,
  - the accused acted with good and honest intentions,
  - and the purpose of publishing or sharing the information was justifiable and not malicious,
- then the truth shall serve as a full and complete defense, and the accused shall not be punished for their actions.

In such cases, the Grand Jury shall decide both the facts and the law, without interference from judges or attorneys.

*Intent: This article affirms the power of truth as a complete legal defense, preserving the rights of individuals to speak honestly and defend just actions.*

### **Article 41 – Right to Request Grand Jury via Affidavit**

We, the People, agree that whoever brings evidence of a wrong can ask for a lawful Grand Jury to evaluate the evidence. The presentment must be in the form of a written affidavit.

*Intent: This article guarantees the People's access to justice through Grand Jury review based on sworn evidence, empowering citizen-led accountability.*

#### **Article 42 – Presentment or Indictment Required for Charges**

We, the People, agree that no living Man or Woman may be charged with a crime unless there is a formal accusation through a lawful presentment, indictment, or impeachment. Such actions must come from proper lawful authority established by this Bilateral Social Compact Agreement within Washoe County, Nevada, a State of the Union.

*Intent: This article preserves lawful due process by requiring proper, constitutional procedures before anyone can be charged with a crime.*

#### **Article 43 – No Corruption of Blood or Forfeiture of Estate**

We, the People, agree that no conviction shall punish a person's family or heirs, or cause the loss of property or inheritance of heirs. A person's wrongdoing cannot be used to take away the rights, name, or estate of their children or descendants unless these estates, properties, or inheritance were a direct result of the convicted's unlawful actions and guilt, in which case 7x restitution applies to non-estranged, benefiting family members.

*Intent: This article protects innocent family members from being penalized for the crimes of their relatives while allowing recovery in cases of unjust enrichment derived from wrongdoing.*

#### **Article 44 – Ban on Ex Post Facto Laws**

We, the People, agree that all biblical laws already exist and are enforceable and that retrospective, non-biblical laws—punishing acts committed before the existence of such laws and by them only declared penal or criminal—are oppressive, unjust, and incompatible with rightful liberty. Wherefore, no ex post facto law shall ever be made by any local self-governing community formed under this Bilateral Social Compact Agreement within Washoe County, Nevada State, a State of the Union within The united States of America; with the only exception being physical, spiritual, emotional, psychological, neurological harm inflicted upon a man, woman, and/or their posterity or property.

*Intent: This article prohibits retroactive criminalization of actions, protecting individual liberty, while allowing exceptions in cases of provable harm.*

#### **Article 45 – Protection of Contracts**

We, the People, agree that no law impairing the obligation of contracts shall ever be passed with the following exceptions: one-sided adhesion contracts, implied contracts, and the like. In addition, the Law Form of any segment of government may not be altered or abolished without the consent of We the People as evidenced by an amendment to the Constitution for the united States of America. Nor shall any law or contract be made in violation of this Bilateral Social Compact Agreement.

*Intent: This article preserves the sanctity of lawful contracts while disallowing coercive or unjust agreements and unlawful changes to governance structures.*

#### **Article 46 – Right to Peaceably Assemble and Legislate**

We, the People, agree that we always have the right to peacefully gather, discuss matters that affect the public good, and work together to create laws and limits on government power through

our assemblies. These assemblies exist to serve the general welfare of the People who have signed this Bilateral Social Compact Agreement.

*Intent: This article affirms the unalienable right to assemble and self-govern, ensuring that collective decision-making remains rooted in the People.*

#### **Article 47 – Right to Bear Arms for Defense**

We, the People, agree that all men and women in Washoe County have the right to keep and bear arms for a well-regulated militia under God’s law and common law.

*Intent: This article safeguards the People's right to self-defense and community protection through the lawful possession of arms.*

#### **Article 48 – Consent Required for Government Contracts and Participation**

No contract, statute, license, or administrative process shall be presumed to apply to an individual unless entered into knowingly, voluntarily, and intentionally. Silence, failure to rebut, or ignorance shall not constitute consent to government, corporate, organization, etc. or related systems jurisdiction or administrative control.

*Intent: This article ensures that no authority or obligation can be imposed without explicit, informed, and voluntary consent, protecting individuals from coercive or deceptive governance practices.*

#### **Article 49 – Right of Jury Nullification in Defense of Liberty**

We, the People, affirm that all jurors in Washoe County, when seated in a lawful common law court, retain the full right and duty to judge not only the facts of a case but also the justness of the law itself. Jurors shall be clearly informed of their power to nullify any statute, regulation, or ordinance that is unjust, unconstitutional, or contrary to natural law. Washoe County jurors have the right to annul unconstitutional laws. This includes the ability to render a “not guilty” verdict for any defendant prosecuted under such a law. All instructions to jurors shall include this right, and any attempt to hide, distort, or deny this authority shall be deemed a violation of the People’s rights and prosecuted accordingly under God’s law and common law.

*Intent: This article empowers jurors to act as a final safeguard against unjust laws, affirming their role as defenders of liberty and constitutional integrity.*

#### **Article 50 – Authority of Grand Juries to Revoke Harmful Corporate Charters**

We, the People, affirm that common law grand juries in Washoe County have the lawful authority to revoke corporate charters, impose civil penalties, and pursue criminal prosecutions against any corporation or business entity that causes harm to the life, liberty, property, or health of any man or woman. This authority is grounded in God’s law and common law and shall be exercised without interference from external agencies. All corporate privileges are conditional upon lawful behavior and public trust.

*Intent: This article restores community power to hold corporations accountable for harm, revoking their privileges when they breach public trust or cause injury.*

## 6. Identity & Status Protections

- Article 51 – Right to Change One’s Legal Status
- Article 52 – Legal Distinction between Natural Persons and Legal Fictions
- Article 53 – Ban on Social Security numbers as jurisdictional tool
- Article 54 – End hospital birth registration protocol

### **Article 51 – Right to Change One’s Legal Lawful Status**

Every individual has the inherent right to change or correct their legal lawful status, including any government-imposed identifiers, without penalty or prejudice. No person shall be forced to accept or operate under a commercial or corporate status imposed by the state, federal government, or any foreign body. Identity, citizenship, and jurisdictional affiliations must be entered into voluntarily and with fully informed consent.

*Intent: This article protects individual sovereignty by ensuring that no government entity can impose a legal status or identity without voluntary, informed consent.*

### **Article 52 – Legal Lawful Distinction between Natural Persons and Legal Fictions**

No person shall be compelled to identify or be treated as a corporate or legal fiction (e.g., all-capital-letter names on government documents) without full disclosure and consent. Legal Lawful language must not obscure a person's status as a living, breathing human being with unalienable rights.

*Intent: This article secures recognition of individuals as sovereign beings, not corporate constructs, and demands transparency and consent in all legal identification practices.*

### **Article 53 – Ban on Social Security Numbers as Jurisdictional Tool**

We the People agree that the following is outlawed as it pertains to a Social Security number or similar number:

- a. Any private membership association or any other association to require or ask for a Social Security number or similar number; and
- b. To associate a Social Security number or similar number to any type of sovereign or citizen status; and
- c. To use a Social Security number or any similar number in any form of a judicial proceeding or judiciary proceeding; and
- d. To be used as a point or Post of jurisdiction;

*Intent: This article prevents the misuse of Social Security numbers to unlawfully assert jurisdiction or create implied legal relationships without consent.*

### **Article 54 – End Hospital Birth Registration Protocol**

We the People agree that hospitals in Washoe County shall issue a Certificate of Live Birth, recorded locally, under God’s law and common law, rejecting all U.S. state birth certificate, footprints, and other protocols for use in the creation of the modern-day “Slave.” These practices

are null and void as a practice in Washoe County, Nevada State, a State of the Union within The United States of America.

*Intent: This article restores lawful birth documentation practices rooted in community jurisdiction, rejecting corporate state-created identities imposed at birth.*

## **7. Economic & Financial Sovereignty**

- Article 55 – Ban on monopolies and private contracts of allegiance
- Article 56 – Ban on forced digital currency; use of gold/silver-backed coinage
- Article 57 – Forensic audit (also listed under Government Structure)
- Article 58 – Lawful Taxation, Transparency, and Oversight
- Article 59 – Equal Economic Accountability and Tariff-Based Revenue
- Article 60 – Abolition of Property Taxes and Protection of Educational Funds
- Article 61 – Ban on Foreign Ownership of Property and Enterprise
- Article 62 – Rejection of Federal Income Tax and Demand for Restitution
- Article 63 – Prohibition of Insurance Corporations and Community-Based Alternatives
- Article 64 – Prohibition of False, Harmful, and Unsolicited Advertising

### **Article 55 – Prohibition of Monopolies and Conflicted Private Contracts**

We the People agree that monopolies are incompatible with a free and just Republic and are therefore strictly prohibited.

No public official, private officer, or representative holding any position of authority under this Bilateral Social Compact shall enter into private contracts, agreements, or financial relationships that create conflicting allegiances or deny the People equal protection or due process of law.

This includes, but is not limited to:

- Bribery
- Kickbacks
- Money laundering
- Backdoor corporate agreements
- Private gain from public influence

Any individual found in violation of this article shall be immediately suspended from their duties, by majority vote of the People of this Compact, pending final judgment through judicial due process under Common Law.

Such violations shall be considered acts of treason against the Republic, and carry severe civil and criminal penalties, including full restitution, permanent removal from office, and potential imprisonment, as determined by a lawful court.

*Intent: This article ensures government integrity by prohibiting monopolistic practices and financial conflicts of interest that undermine public trust and lawful governance.*

### **Article 56 – Lawful Money and Protection Against Digital Currency Monopolies**

We the People agree that only gold or silver coin shall be recognized as lawful money for the payment of debts, in accordance with the original Constitution for the Republic of the United States of America (Article I, Section 10).

Any attempt by government, banks, corporations, or international bodies to impose a digital currency as the sole or mandatory medium of exchange—whether by law, policy, or coercion—is unconstitutional, unlawful, and hereby forbidden.

This includes, but is not limited to:

- Digital-only currencies that eliminate or outlaw cash, coin, or physical tender;
- Currency systems that require the use of implanted chips, biometric markers, or other electronic devices;
- Any digital payment system that denies individuals free and voluntary access to alternative lawful tender, such as gold and silver.

Additionally, the implantation of any device—digital, electronic, or nano-based—into the body or personal property of any individual, for the purposes of identification, commerce, surveillance, or health tracking, is strictly prohibited in all forms, unless:

1. Full, truthful disclosure is given; and
2. Voluntary, informed, and uncoerced consent is provided by the individual.

Nevada State shall uphold the use and circulation of gold and silver-backed coinage or currency only, as authorized under the Constitution and reaffirmed by this Bilateral Social Compact Agreement. All other forms of currency shall be considered private tender, and their use shall not be mandated or enforced by law; and

*Intent: This article defends economic sovereignty by mandating gold and silver as lawful money, while prohibiting coercive digital currency systems and biometric commerce tied to centralized control.*

#### **Article 57 – Forensic Audit of County Financial Affairs**

We the People agree that all financial affairs involving public funds, assets, revenues, and expenditures within Washoe County, Nevada State, shall be fully transparent and accountable to the People.

To ensure this:

1. A Committee of Safety, composed of men and women elected by the County Assembly under this Bilateral Social Compact, shall have the lawful authority to request and oversee a forensic audit of all county-level financial activities.
2. A forensic audit may be initiated:
  - o Annually by default; or
  - o At any time the County Assembly or Committee of Safety determines that irregularities, suspected fraud, or financial mismanagement may exist.
3. All audits shall be conducted by an independent, private forensic accounting firm selected by the Committee of Safety, and operating under God’s Law and Common Law jurisdiction.
4. The full results of each audit, including all findings, records, and recommendations, shall be published publicly within 30 days of the audit’s completion.
5. Any individual—elected, appointed, or contracted—found to have knowingly participated in fraud, misappropriation of funds, or unlawful financial practices shall be removed from office and subject to full civil and criminal penalties under this Compact. This provision applies not only to county funds but also to any future lawful currency,

coinage, trust, or treasury system established within Washoe County after the dismantling or withdrawal from unconstitutional systems such as the Federal Reserve; and

*Intent: This article provides a permanent, transparent mechanism for independent financial oversight to prevent fraud, restore fiscal accountability, and ensure public trust in county-level governance.*

### **Article 58 – Lawful Taxation, Transparency, and Oversight**

We the People agree that no taxes, fees, or financial assessments shall be imposed upon the People of Washoe County except in full alignment with:

1. The original Constitution for the Republic of the United States of America; and
2. The expressed authority of this Bilateral Social Compact Agreement.  
To preserve the People’s consent and lawful self-governance:
  - All proposed taxes or fees must be specifically approved by a supermajority vote of the County Assembly.
  - Every tax or fee must be fully disclosed and itemized in plain language, showing where the funds are collected from, how they will be used, and who will be responsible for oversight.
  - All tax records and expenditures shall remain open to public review at all times, with no exceptions or classification.Any attempt to impose hidden, indirect, or unauthorized taxes—whether through government, corporate partnerships, or external agencies—shall be considered fraudulent and unlawful, and subject to prosecution under this Compact; and

*Intent: This article ensures taxation with full consent, transparency, and accountability to prevent hidden levies, preserve economic freedom, and reinforce lawful self-governance.*

### **Article 59 – Equal Economic Accountability and Tariff-Based Revenue**

We the People agree that no company, industry, or corporation within Washoe County shall receive special tax privileges, exemptions, or preferential treatment under any circumstance. To ensure fairness, transparency, and economic integrity:

1. All business entities shall operate under the same lawful standard of economic contribution, without political favoritism or backdoor deals.
2. Corporate income taxes shall be abolished in favor of a tariff-based system that supports only a minimally sized, constitutionally limited government, as established under this Bilateral Social Compact.
3. All public revenue collection shall be:
  - o Itemized, disclosed, and accessible to the People at all times;
  - o Non-punitive toward local innovation, employment, or investment;
  - o Proportional to use and impact, and applied equally without bias.Any government official or entity found to be granting or receiving unlawful economic advantages shall be subject to full civil and criminal penalties, including restitution and permanent disqualification from public service or contracting.

*Intent: This article mandates a level economic playing field through equal taxation principles and a transparent tariff-based revenue system, prohibiting favoritism and corruption.*

### **Article 60 – Abolition of Property Taxes and Protection of Educational Funds**

We the People agree that property taxes are a form of unlawful and perpetual rent on private ownership and are therefore hereby abolished in Washoe County, Nevada State.

To uphold lawful governance and the will of the People:

1. No property—real, private, or inherited—shall be taxed by any state, local, or county authority.
2. Any taxes or revenues designated for education shall be used exclusively for that purpose, with no diversion, delay, or reassignment to other programs, departments, or budget line items.

To ensure accountability and deter corruption:

- No bond-related ballot measures may be used to justify reallocation of existing or future education funds.
- Any individual who diverts, launders, misappropriates, or steals educational monies shall be held personally liable for:
  - o Full financial restitution,
  - o Civil penalties and fines, and
  - o Criminal penalties, including a minimum 5-year prison term.
- Offenders shall also face permanent disqualification from holding any public office or public service role.

The People of Washoe County declare that funding for essential public services—including education—must be rooted in transparent, lawful, and non-punitive revenue systems that respect private ownership and the sovereignty of the People; and

*Intent: This article abolishes unlawful property taxation and establishes strict protections for education funding to prevent financial abuse and uphold private property rights.*

### **Article 61 – Ban on Foreign Ownership of Property and Enterprise**

We the People agree that the land, resources, and economy of Washoe County, Nevada State, shall remain under the ownership and control of the American People.

To protect local sovereignty, national security, and generational stewardship:

1. No foreign individual, government, corporation, or entity may own, directly or indirectly, any land, property, business, building, resource, equipment, or livestock within Washoe County.
2. No business operating within the county may be owned or controlled by an entity with more than 10% foreign ownership or influence.
3. All current foreign-owned property or holdings shall be subject to mandatory divestment within a reasonable transition period, not to exceed 12 months, as established by the County Assembly.

Failure to comply shall result in:

- Revocation of ownership rights,
- Seizure and public auction of such properties to lawful American citizens or entities,

and

- Bans on future participation in the county’s economy.

This article shall be upheld under the authority of this Bilateral Social Compact Agreement and shall not be overridden by any international treaty, corporate pressure, or federal policy; and

*Intent: This article ensures that Washoe County’s land and economy remain under American control by banning foreign ownership and requiring divestment of existing foreign-held assets.*

### **Article 62 – Rejection of Federal Income Tax and Demand for Restitution**

We the People declare that Washoe County is a Free County within the Free State of Nevada, governed by the original Constitution for the Republic of the United States of America and this Bilateral Social Compact Agreement.

Accordingly:

1. Federal income taxes are hereby deemed unconstitutional, unlawful, and without legal standing in Washoe County, as they violate the foundational principles of limited government and the unalienable rights of the People to the fruits of their labor.
2. No resident of Washoe County shall be compelled to file, pay, or otherwise comply with federal income tax obligations, whether under the IRS or any future equivalent agency.
3. All past income taxes unlawfully collected from the People of Washoe County—including those who lawfully relocated from other states seeking refuge from federal overreach—must be fully repaid by the responsible federal entities.
4. Repayment shall include:
  - o Full principal restitution,
  - o Constitutional interest penalties, and
  - o A maximum deadline of 60 days from the date of this article’s ratification.
5. Any attempt to enforce federal income tax law within Washoe County shall be considered an act of unlawful coercion and economic warfare against the People, and those responsible—public or private—shall be subject to prosecution under this Compact. This article shall be defended by the authority of the People and the County Assembly, and shall not be overruled by any federal statute, court, or agency not recognized under the original Republic Constitution.

*Intent: This article nullifies the application of federal income tax in Washoe County, demands restitution for prior unlawful collection, and prohibits any enforcement actions by federal agents or entities.*

### **Article 63 – Prohibition of Insurance Corporations and Community-Based Alternatives**

The People declare that all insurance corporations—whether for health, life, property, liability, or otherwise—are unlawful monopolies that violate economic liberty, inflate essential service costs, and compel dependence on corrupt corporate interests. These entities are hereby banned from operating within Washoe County.

#### **Section 1 – Abolition of All Insurance Schemes**

- No entity or person may sell, market, or enforce any form of insurance contract within Washoe

County, including but not limited to medical, auto, property, life, or professional liability coverage.

- Any attempt to enforce an insurance mandate or policy contract within the jurisdiction shall be null and void and punishable by law.

## **Section 2 – Lawful, Voluntary, People-Based Alternatives**

In lieu of insurance, voluntary community-based alternatives are authorized:

- **Mutual Aid Health Pools:** Voluntary opt-in groups where members contribute monthly to a shared fund, managed transparently at the County Assembly level. Only those with low-risk health habits and lifestyle choices are eligible to reduce collective burden.
- **Life Legacy Trusts:** Families and community members may establish joint savings or trust pools designed to provide death benefits or elder care through cooperative agreement, with no involvement from corporate or banking institutions.
- **Disaster and Property Relief Co-ops:** Local co-ops may be formed to assist with losses from fire, weather events, or other emergencies through consensual pooling of community resources, approved and audited by the Assembly.

## **Section 3 – Oversight and Transparency**

- All mutual aid or cooperative fund systems must register with the Washoe County Assembly.
- Financial records shall be disclosed quarterly to the Assembly Oversight Committee and made publicly accessible.
- A minimum of three elected stewards shall manage each fund, with full fiduciary duty and personal liability for misconduct.

## **Section 4 – Anti-Fraud Provisions and Penalties**

- Any act of fraud, embezzlement, misrepresentation, or abuse in relation to community-based pooling systems shall result in full restitution, permanent disqualification from future participation, and criminal penalties up to full forfeiture of assets and imprisonment.
- Collusion with banned insurance entities shall be considered treason against the People’s economic sovereignty and punished accordingly.

## **Section 5 – Sovereign Right to Self-Reliance**

- No individual shall be compelled to participate in any pooling system. The People retain the sovereign right to self-fund, self-manage, or decline financial risk protections as an expression of personal liberty and responsibility.

*Intent: This article abolishes corporate insurance schemes, promotes lawful voluntary alternatives, and reinforces the People’s right to manage risk without coercion or corporate interference.*

## **Article 64 – Prohibition of False, Harmful, and Unsolicited Advertising**

### **Section 1 – Right to Protection from Deceptive Influence**

Every individual has the right to be free from unsolicited, false, harmful, or manipulative advertising in any form—whether printed, digital, audio, or visual—that seeks to exploit human

psychology, misrepresent facts, induce unhealthy behavior, or impose unwanted commercial influence.

## **Section 2 – Definition of Prohibited Advertising**

Advertising shall be deemed unlawful and prohibited if it:

- Is false or misleading in content or omission
- Promotes harmful, addictive, or experimental products or services
- Targets minors or vulnerable populations with manipulative techniques
- Is delivered without express prior consent of the recipient
- Utilizes surveillance, biometric data, or AI profiling for behavioral targeting
- Impersonates a trusted source or appears as news, education, or public safety messaging without disclosure

## **Section 3 – Prohibition of Mass Unsolicited Commercial Messaging**

All forms of mass unsolicited commercial advertising (via email, SMS, telephone, print, television, radio, or online platforms) are banned unless the recipient has affirmatively opted in. Repeated violations shall result in escalating penalties, including permanent banning from the market.

## **Section 4 – Massive Deterrents and Penalties**

Violators shall be subject to:

- Fines not less than \$500,000 per offense for corporate entities
- Seizure and forfeiture of revenues and assets derived from prohibited advertising
- Civil liability to all harmed parties
- Personal liability and prosecution of corporate officers for knowing violations
- Revocation of business licenses and permanent prohibition from operating in Washoe County

## **Section 5 – Enforcement and Citizen Oversight**

- A standing Public Integrity Board under the County Assembly shall investigate and enforce this article.
- The Board shall maintain a public registry of offenders and publish all findings, penalties, and enforcement actions.
- Verified citizen complaints must be acted upon within 30 days, with remedies and restitution where applicable.

## **Section 6 – Whistleblower Protections and Bounties**

Whistleblowers who expose unlawful advertising practices shall be protected from retaliation and may receive up to 25% of collected penalties as a bounty if their testimony results in successful enforcement.

*Intent: This article prohibits deceptive and coercive advertising practices, protects the public from psychological and commercial exploitation, and establishes severe penalties and oversight mechanisms for violators.*

# **8. Educational Reform & Youth Protection**

- Article 65 – Educational sovereignty
- Article 66 – Parental Rights
- Article 67 – Transparency and third-party audits for federal funds received by schools
- Article 68 – Teacher and School Board Selection, Oversight, and Integrity Standards

**Article 65 – Educational Sovereignty, Curriculum Integrity, and Required Instruction**

We the People of Washoe County, Nevada State, declare that education shall be governed locally and lawfully, rooted in truth, liberty, and the founding principles of the Republic. No external body, including the federal government or foreign influence, shall dictate or impose educational content, policy, or ideology within our county schools.

Accordingly:

1. All federally imposed or ideologically driven curriculums are hereby banned, including but not limited to:
  - Common Core Standards
  - Critical Race Theory (CRT)
  - Social Emotional Learning (SEL)
  - Transgender indoctrination programs
  - Climate-related propaganda or global control agendas disguised as science
  - Any other program that promotes collectivism, moral relativism, or political indoctrination
2. Communism, Marxism, Socialism, or any form of government or philosophy repugnant to our Constitution, Bill of Rights, or the Declaration of Independence may only be taught as historical failures that violated human rights and led to oppression. These systems may never be presented as legitimate or viable alternatives to a free and moral Republic.
3. Any individual—teacher, administrator, or public official—who promotes, enforces, or conceals unlawful educational content in violation of this Article shall:
  - Be immediately removed from any position of trust or public service,
  - Forfeit all publicly funded retirement and disability benefits tied to that role, and
  - Be permanently barred from educational governance or employment within the county.
4. No federally created or affiliated curriculum or funding mechanism shall override local control. Washoe County reserves full educational sovereignty under this Bilateral Social Compact.
5. All public and private schools within the county shall include instruction on:
  - The true history of the United States and its founding principles,
  - The Declaration of Independence, Constitution, and Federalist Papers,
  - The nature and importance of unalienable rights,
  - Entrepreneurship and free enterprise,

- Cursive handwriting, music, and art, as foundational disciplines for creative and intellectual development.

This article shall be enforced under the authority of the County Assembly and the People, and may not be undermined by funding threats, external accreditation agencies, or federal mandates.

*Intent: This article establishes local educational sovereignty, bans ideological federal curriculums, and mandates truthful, constitutionally grounded instruction.*

### **Article 66 – Parental Rights and Prohibition of Mandated Health Requirements in Schools**

We the People of Washoe County affirm that parents and legal guardians hold the primary and inviolable authority over the health and medical decisions of their children. Accordingly:

1. School boards and educational institutions shall have no authority to mandate any medical procedures or health-related requirements, including but not limited to:
  - Vaccinations
  - Masking
  - Testing
  - Medical screenings
  - Pharmaceutical treatments
2. Parents and guardians may freely enter school property to withdraw their children at any time, and no school official, law enforcement agency, or third-party authority shall interfere, intimidate, or restrict this right under any circumstance.
3. The use of police or security forces to enforce medical mandates or suppress parental involvement is strictly prohibited. Any such action shall trigger:
  - Immediate removal and replacement of the school board and complicit administrators, and
  - A full civil and criminal investigation, including the right of affected families to initiate class-action lawsuits for damages and rights violations.
4. Whistleblowers or staff members who expose such violations in good faith shall be protected from retaliation and may request amnesty for previously coerced participation.
5. Any faculty, staff, or official who knowingly participates in coercion, intimidation, or suppression of parental rights, medical freedom, or the free flow of truthful information shall be held accountable as follows:
  - Equal liability as those who directly implemented the harm;
  - Full personal and professional accountability under the Nuremberg Code;
  - Potential criminal charges for complicity in psychological, emotional, or physical harm.
6. The preparation or dissemination of false or misleading health information, whether through policy, instruction, or enforcement, including “just following orders,” is

recognized as the use of a dangerous psychological weapon. This conduct shall be punishable under the Nuremberg Code and this Bilateral Social Compact.

Let it be known: "Do no harm, hide no help" shall be the minimum standard for lawful conduct in educational settings.

*Intent: This article safeguards parental medical authority over children, prohibits school-mandated health procedures, and criminalizes coercion, suppression, or harm by educational institutions or their agents.*

### **Article 67 – Transparency and Public Oversight of Federal Education Funds**

We the People of Washoe County declare that all federal or external funds received by public schools, including but not limited to the Elementary and Secondary School Emergency Relief (ESSER) Fund, shall be subject to full transparency, strict accountability, and public direction.

Accordingly:

1. All such funds must be used exclusively for direct educational purposes that serve the highest academic, moral, and developmental interests of the children within Washoe County.
2. Full public disclosure is required, detailing:
  - The total amount of funds received;
  - A clear and itemized report of how each dollar is spent;
  - All contracts, vendors, or entities paid with such funds.
3. An independent, third-party forensic audit of all federal education funds shall be conducted annually or upon public request by a vote of the County Assembly. The audit findings shall be made fully available to the public within 30 days of completion.
4. Any funds not used for lawful, approved educational purposes shall be deemed surplus, and the allocation of such surplus shall be determined by a public vote of the People of Washoe County. These funds may only be redirected to programs that align with the principles and purposes of this Bilateral Social Compact.
5. Any individual found misappropriating or concealing the use of federal education funds shall be subject to:
  - Immediate removal from position,
  - Full restitution and civil penalties, and
  - Criminal charges where applicable.

This article ensures that federal influence shall never override the educational sovereignty of the People, and that all funding serves only the lawful education and well-being of our children.

*Intent: This article demands full transparency and public control over federal education funds, with audits, public reporting, and lawful use tied to the will of the People.*

## **Article 68 – Teacher and School Board Selection, Oversight, and Integrity Standards**

### **Section 1 – Teacher Selection Based on Merit and Community Values**

All teachers shall be selected through a transparent, merit-based process free from political, ideological, or union interference. Requirements shall include:

- Demonstrated mastery in subject matter, communication skills, and classroom management
- Strong moral character and alignment with community values, including respect for parental authority and the natural rights of children
- A working knowledge of constitutional and common law principles
- Background checks, psychological evaluations, and interviews conducted by a local Education Integrity Board composed of parents, educators, and community members

### **Section 2 – No Tenure or Unaccountable Positions**

Teaching positions are not guaranteed nor subject to tenure. Ongoing employment shall be conditional upon:

- Annual reviews of performance, character, student progress, and parent feedback
- Periodic classroom observation by independent panels
- Continual adherence to standards of professional conduct and fidelity to truth, not ideology

### **Section 3 – School Board Selection Process**

Members of school boards shall be selected by a process similar to judicial and law enforcement appointments:

- Candidates shall be nominated and vetted by the County Assembly
- Final appointments shall be made by the Governor and confirmed by the Senate
- All candidates must be free from lobbying ties, political parties, teacher unions, federal agencies, and corporate education entities

### **Section 4 – Oversight and Transparency**

- School boards and administrators shall be subject to regular performance audits, financial reviews, and curriculum evaluations by citizen panels
- All meetings, decisions, and materials must be publicly accessible and documented in plain language
- Parents shall retain final authority on the appropriateness of all instructional content presented to their children

### **Section 5 – Penalties for Corruption or Malfeasance**

- Any school board member, teacher, or administrator found guilty of fraud, abuse, ideological coercion, or curriculum manipulation shall be subject to immediate removal and prosecution

- Civil and criminal penalties shall apply to those who use their position to indoctrinate, discriminate, exploit, or deceive children and families

*Intent: This article mandates local, merit-based oversight of teachers and school boards, forbids ideological manipulation, and enforces parental and public authority over education.*

## 9. Medical Autonomy & Public Health

- Article 69 – Prohibits forced medical interventions
- Article 70 – Forbids mandatory vaccinations, requires full disclosure
- Article 71 – Medical discrimination
- Article 72 – Bans vaccine passports and their enforcement
- Article 73 – Outlaws bribery related to accepting vaccinations or medical procedures
- Article 74 – Cause of Death requirements
- Article 75 – Alternative medicines
- Article 76 – Medicinal herbs and plants are considered natural gifts from the Creator/God

### **Article 69 – Prohibition of Forced Medical Interventions and Coercive Health Propaganda**

We the People of Washoe County affirm that every individual holds the exclusive right to bodily autonomy and informed consent, and that no forced medical interventions of any kind shall be tolerated.

Accordingly:

1. No government agency, employer, school, business, or individual may impose or enforce any medical intervention, including but not limited to:
  - Mandatory masking,
  - Forced or coerced medication or injections,
  - Psychological manipulation through fear-based propaganda,
  - Ritualistic or symbolic practices (e.g., spells, sorcery, veils, or spiritual coercion) under any label or agenda.
2. No private business shall be compelled by government mandate to post signs, enforce policies, or deny entry or service to individuals based on their medical choices or appearance.
3. Any attempt to impose such unlawful interventions—whether directly or by proxy—shall constitute a violation of the Nuremberg Code and this Bilateral Social Compact, and shall be treated as:
  - A crime against humanity,
  - A violation of God-given unalienable rights, and
  - An offense punishable by civil and criminal prosecution, including potential loss of business license, office, or public service eligibility.

*Intent: This article protects medical freedom and bodily autonomy, banning coercion, propaganda, and spiritual manipulation under the guise of health mandates.*

## **Article 70 – Prohibition of Mandatory Vaccinations and Requirement for Full Disclosure and Informed Consent**

We the People of Washoe County affirm that all medical interventions, including vaccinations, must be voluntary, fully disclosed, and based on the principle of informed consent, without coercion or concealment.

Accordingly:

1. Mandatory vaccinations of any kind are strictly forbidden, including but not limited to:
  - Injections, implants, or delivery mechanisms involving nano-technology,
  - Biometric tracking, or medical identifiers.
2. No vaccine or similar product may be administered unless it meets all of the following conditions:
  - Thorough safety testing, including long-term animal and human trials (tracked for no less than 50 years if accelerated methods are not possible);
  - Independent third-party peer review, free from conflict of interest;
  - No financial or procedural interference by pharmaceutical manufacturers in study design, subject selection, regulatory approval, or public communication.
3. No individual or entity involved in the manufacture, promotion, distribution, or administration of any vaccine may be shielded from liability through waiver, contract, emergency declaration, or statutory immunity. All liability remains personal and absolute.
4. Before any vaccine is offered or administered, the individual must receive a full disclosure document that includes:
  - A complete list of ingredients,
  - Known and potential side effects,
  - Summary of safety testing, published studies, and documented risk assessments,
  - The full names and roles of the administering personnel and prescribing physician.
5. The individual must autograph a written informed consent form affirming they received, understood, and accepted the risks. Any absence of such disclosure and consent constitutes a violation of international law, including the Nuremberg Code.
6. Any individual who:
  - Administers, promotes, or mandates a vaccine they themselves have not taken, or
  - Conceals or misrepresents any part of the vaccine's content or history, shall be considered complicit in medical fraud and a crime against humanity, and subject to civil and criminal penalties under this Compact.

7. Any person who received the Covid-19 injection or similar without full disclosure of its contents and risks has the right to pursue legal action against all responsible parties, including administrators, institutions, and manufacturers, for damages and remedy.

*Intent: This article prohibits forced vaccinations, requires complete informed consent, eliminates liability shields, and empowers harmed individuals to pursue justice.*

### **Article 71 – Protection from Medical Discrimination, Coercion, and Retaliation**

We the People of Washoe County declare that every individual has the unalienable right to make private medical decisions without fear of coercion, retaliation, or discrimination. These rights apply equally to adults, children, families, and guardians.

Accordingly:

1. No individual shall be denied employment, demoted, dismissed, barred from education, or denied access to public services or private businesses based on:
  - Vaccination status;
  - Medical choices for themselves or their dependents;
  - Refusal to disclose private medical information.
2. An individual's medical history, status, and decisions are private and protected, and may not be used to limit or interfere with:
  - The right to work and earn a fair wage,
  - The right to travel freely,
  - The right to healthcare and medical treatment,
  - The right to parent and care for loved ones,
  - The right to engage in commerce, education, or public life.
3. These protections are guaranteed under the authority of this Bilateral Social Compact Agreement, and no agency, employer, institution, or individual may override them by policy, mandate, or contract.
4. Any violation of these protections—including retaliation, coercion, bribery, or exclusion based on medical decisions—grants the harmed party full legal standing to pursue lawful remedy, including restitution, penalties, and criminal charges where appropriate.
5. The preparation, dissemination, or enforcement of false or misleading information—whether medical, legal, or social—is considered a psychological weapon and a violation of the Nuremberg Code. This includes the defense of “just following orders.”
6. Any deliberate suppression of truth, threats to individuals who share truth, or acts of intimidation intended to silence dissent or enforce medical conformity shall be treated as crimes against humanity, with full penalties applied under international and common law. Let it be known: “Do no harm, hide no help” is the lawful and moral standard by which all individuals, institutions, and authorities shall be judged in Washoe County.

*Intent: This article protects individuals from all forms of discrimination or coercion based on private medical decisions and ensures accountability for violations under the highest legal and moral standards.*

### **Article 72 – Prohibition of Vaccine Passports and Medical Status-Based Restrictions**

We the People of Washoe County declare that all individuals are endowed with unalienable rights which shall not be conditioned upon or restricted by any medical status, record, or disclosure.

Accordingly:

1. Vaccine passports, or any system, device, application, ID, or document used to track, prove, or verify a person’s vaccination status or medical history, are strictly prohibited within Washoe County.
2. No individual shall be:
  - Required to show medical records or status to access public or private property, employment, education, travel, or services;
  - Denied participation in society based on any medical choice or disclosure refusal.
3. The creation, enforcement, or promotion of such systems—whether by private business, public agency, school, employer, or government—shall be considered unlawful, discriminatory, and a violation of this Bilateral Social Compact Agreement.
4. Any attempt to implement or require a vaccine passport or medical-status-based restriction shall result in civil and criminal penalties, including:
  - Fines,
  - Loss of licensure or position, and
  - Legal liability for damages.

*Intent: This article permanently bans vaccine passports and ensures that no individual’s freedom or participation in society is conditioned on medical status or disclosure.*

### **Article 73 – Prohibition of Bribery and Coercion Related to Medical Procedures**

We the People of Washoe County affirm that medical decisions must be made freely and without coercion, manipulation, or bribery.

Accordingly:

1. Bribery, coercion, or inducement of any kind—financial, social, professional, or otherwise—offered in exchange for acceptance of any medical procedure, including vaccinations, is strictly prohibited and unlawful.
2. This includes but is not limited to:
  - Cash payments or financial rewards,
  - Access to goods, services, events, or employment,

- Academic or athletic privileges,
  - Threats of loss of access, reputation, custody, or opportunity.
3. Any person, agency, corporation, school, employer, or government entity found guilty of:
- Offering such inducements,
  - Participating in the implementation of coercive medical programs, or
  - Promoting such actions under a propaganda agenda,
- shall face civil liability, criminal prosecution, and permanent disqualification from public trust or authority within Washoe County.
4. Individuals who were coerced or bribed into accepting any medical procedure—especially under misinformation or incomplete disclosure—shall retain the right to:
- File civil claims for damages,
  - Pursue criminal complaints, and
  - Seek public remedy under this Bilateral Social Compact.
- Let it be known: All medical consent must be freely given, fully informed, and free of external pressure or incentive. Anything less constitutes fraud and a violation of human rights.

*Intent: This article prohibits all forms of bribery and coercion related to medical procedures and ensures full legal remedy for victims of such practices.*

#### **Article 74 – Cause of Death Verification & Medical Accountability**

We, the People, declare that no hospital, medical facility, or healthcare provider in Washoe County shall report or record a death as caused by COVID-19, SARS, or any future declared illness or engineered bioweapon without verifiable, objective evidence. Tangible proof must include diagnostic test results, confirmed symptoms, and full transparency of treatment protocols used prior to death.

Hospitals, physicians, and healthcare providers shall not receive any form of financial reward, incentive, or compensation based on the cause of death listed on medical records, including from government or corporate sources. This policy eliminates the perverse incentive to misclassify deaths for profit or political narrative.

Standard respiratory treatments—such as nebulizers, oxygen therapy, and safe ventilator settings—must be prioritized over experimental or high-risk treatments unless fully informed consent is given. Medications known to cause organ damage, such as Remdesivir, shall not be used without documented, patient-specific medical justification and signed consent. Any deaths linked to misuse or misrepresentation of such medications shall trigger full legal liability and investigation into the individuals and institutions involved.

All studies regarding vaccines, including COVID-19 and any future vaccines, must be made available to the public. This includes peer-reviewed data on safety, ingredients, known side effects, and actual risk-benefit profiles. Families shall never be denied access to hospitalized

loved ones, and hospitals must provide appropriate protective equipment for visitors when necessary.

Any employee or whistleblower who exposes misconduct or fraudulent practices in accordance with this Compact shall be eligible for amnesty and protection, provided their actions are truthful and motivated by a duty to uphold the law.

The publication of false information, misinformation, the concealment of harm, the concealment or defaming of alternative cures, or the exploitation of human illness for financial or political gain will be prosecuted as crimes against humanity under God's law, the Nuremberg Code, and common law justice.

*Intent: This article mandates verifiable cause-of-death reporting, eliminates profit incentives for misreporting, protects truth-telling whistleblowers, and upholds medical integrity and informed consent.*

### **Article 75 – Equal Access to Natural Medical Treatments and Protection of Truth in Healing**

We the People of Washoe County affirm that every individual has the unalienable right to access safe, natural, and holistic medical treatments and to receive truthful, uncensored information regarding all known cures or beneficial therapies.

Accordingly:

1. Equal opportunity and legal protection shall be granted to all natural, holistic, and non-pharmaceutical healing practices, including but not limited to herbal medicine, nutritional therapy, energy-based healing, and integrative wellness modalities.
2. Any known cure or effective treatment for disease—whether natural, alternative, or conventional—must be publicly disclosed, made accessible, and not suppressed under any circumstance. Concealment or censorship of such remedies shall be treated as a crime.
3. The preparation, promotion, or dissemination of disinformation, particularly the suppression of true healing knowledge or the promotion of fraudulent, harmful, or profit-driven treatments, shall be considered the use of a dangerous psychological weapon and prosecuted under the Nuremberg Code and this Compact.
4. Individuals or institutions that:
  - Suppress or censor non-pharmaceutical treatments,
  - Discredit natural cures without valid data,
  - Promote pharmaceutical products through manipulation or false claims, or
  - Threaten, retaliate against, or financially harm those who speak truthfully about healing, shall be held legally and personally accountable under both civil and criminal law.
5. Medical profiteering at the expense of public health shall be deemed unethical and unlawful. All treatment recommendations must prioritize patient well-being over financial interest.

Let it be known: The lawful and moral standard in Washoe County shall be "Do no harm, hide no help." All healing knowledge and treatment options must be made openly available, truthfully evaluated, and never silenced for profit or control.

*Intent: This article guarantees access to natural healing, prohibits suppression of truthful medical information, and enforces ethical standards in treatment.*

### **Article 76 – Protection of Medicinal Herbs and Plants as Natural, Unregulated Gifts**

We the People of Washoe and Humboldt Counties affirm that medicinal herbs and plants are divine gifts from our Creator, given for the health and healing of mankind. As such, they shall be protected from corporate, governmental, or institutional control or interference.

Accordingly:

1. All medicinal herbs, plants, roots, and naturally occurring remedies are hereby recognized as unregulated natural resources, freely available for cultivation, use, and exchange by the People under God’s law and common law.
2. No agency, corporation, or external governing body—including the so-called UNITED STATES Corporation, the FDA, or any affiliated regulatory entity—shall have any lawful jurisdiction or authority to:
  - Restrict, license, or control the growth, use, sale, or sharing of medicinal plants;
  - Criminalize or penalize the personal or communal use of such plants for healing purposes.
3. Local assemblies and the People alone retain the right to self-govern and steward the use of these natural resources, in accordance with moral law and the health and safety of the community.
4. Any attempt by outside entities to impose restrictions, permits, or enforcement actions regarding medicinal herbs or plants shall be deemed null, void, and unlawful under this Bilateral Social Compact.

*Intent: This article affirms the People’s right to access and use natural plant-based remedies without government or corporate interference, recognizing them as gifts from God for healing and wellness.*

## **10. Food & Agriculture**

- Article 77 – Protection of Real Food and Nutritional Standards
- Article 78 – Enforcement of Food Purity and Integrity Across the Entire Supply Chain
- Article 79 – Regulation of Agricultural Inputs and Protection of Natural Food Production
- Article 80 – Protection of the Lawful Sale and Consumption of Raw Food and Beverages

## **Article 77 – Protection of Real Food and Nutritional Standards**

We the People of Washoe County affirm that food is sacred and essential to the health of men, women, and children, and must be defined, regulated, and provided in its pure, unadulterated form, free from corruption, contamination, or manipulation.

Accordingly:

1. “Food” shall be lawfully defined as whole, natural, unprocessed, and nutrient-rich sustenance, intended to support physical, emotional, psychological, neurological, and spiritual well-being. It shall be free from artificial, toxic, addictive, or genetically altered substances.
2. No additive or ingredient shall be permitted in the food supply—public or private—that is known or suspected to cause:
  - Hormonal disruption,
  - Neurological or psychological harm,
  - Addiction, illness, or behavioral instability,
  - Long-term immune suppression or cancer risk.
3. The standards for food purity and safety in Washoe County shall be informed by independent research and moral conscience, including the upcoming food regulations proposed by Robert F. Kennedy Jr., so long as such standards reflect truth, transparency, and the public interest, and are free from corporate influence or industry capture.
4. All food served in public schools—including breakfast, lunch, and snacks—must be:
  - Made from whole, unprocessed ingredients,
  - Free from GMO products,
  - Free from synthetic additives, preservatives, or flavor enhancers,
  - Focused on nourishing and developing healthy minds and bodies for both students and staff.
5. Any violation of this standard, including the introduction of deceptive food products or willful neglect of nutritional safety, shall be considered a violation of public trust and, where applicable, a violation of the Nuremberg Code, subject to legal remedy and personal accountability.

*Intent: This article defines and defends the People’s right to access real, nourishing food, free from toxic additives and global corporate manipulation, with a focus on health, transparency, and public trust.*

## **Article 78 – Enforcement of Food Purity and Integrity Across the Entire Supply Chain**

We the People of Washoe County affirm that the purity, safety, and nutritional integrity of food must be upheld at every stage of its production and delivery—from seed to harvest, from processing to distribution, and finally to consumption.

Accordingly:

1. The standards established in Article 48 for real, unadulterated, and health-supporting food shall apply to the entire food supply chain, including:
  - Seeds, animal feed, soil inputs, and farming practices;
  - Food manufacturing, processing, storage, and packaging;
  - Transportation, retail sales, school and institutional food service.
2. No stage of the supply chain may introduce, allow, or conceal:
  - Genetically modified organisms (GMOs),
  - Harmful chemicals or preservatives,
  - Artificial additives, lab-grown substances, or toxins known to cause physical, mental, or emotional harm.
3. Equal opportunity shall be provided to local farmers, producers, and retailers to grow and sell pure, healthy, and truly natural foods within Washoe County, free from burdensome corporate or federal interference.
4. Any person, corporation, or entity that violates these food purity standards shall be held personally and financially liable, with penalties including:
  - Fines, loss of license, or product seizure,
  - Public disclosure of violations,
  - Possible prosecution for fraud or harm if health consequences are proven.

*Intent: This article shall ensure that clean and nutritious food is not only protected but made more widely accessible to all residents, reinforcing the right to health, sovereignty, and local food independence for current and future generations.*

#### **Article 79 – Regulation of Agricultural Inputs and Protection of Natural Food Production**

We the People of Washoe County affirm that the quality of food begins with the integrity of its production, and that the land, plants, animals, and environment must be protected from harmful, synthetic, or exploitative agricultural practices.

Accordingly:

1. The use of all fertilizers, pesticides, herbicides, fungicides, and soil amendments within Washoe County shall be subject to strict standards of natural origin, ecological safety, and human health compatibility.
2. The following substances and practices are strictly prohibited in the production of food crops and animal feed:
  - Synthetic or petroleum-based fertilizers and chemical pesticides known or suspected to cause cancer, neurological damage, or hormonal disruption (e.g., glyphosate, atrazine);
  - Sewage sludge, industrial waste, or bio-solids applied to farmland;
  - Any genetically modified organisms (GMOs) or gene-edited seeds, plants, or animals;

- Livestock feed containing antibiotics, growth hormones, synthetic vitamins, or non-food fillers;
  - Confined animal feeding operations (CAFOs) that fail to meet humane and sanitary standards.
3. All agricultural inputs used in Washoe County must be fully disclosed and subject to independent safety review by a County-approved board of agronomists, health experts, and citizen advocates.
  4. Only farming practices that support soil health, biodiversity, animal welfare, and long-term sustainability shall be recognized as lawful. Permaculture, regenerative, organic, and indigenous agricultural methods shall be prioritized and supported.
  5. Farmers and food producers who meet these standards shall be eligible for local incentives, preferred certification, and direct-to-public marketing support under County authority.
  6. Any willful violation of these standards—especially if resulting in environmental damage or harm to the People—shall be treated as a breach of the public trust and may include:
    - Civil penalties,
    - Revocation of farm licenses or land use privileges,
    - Criminal charges in cases of proven fraud or reckless endangerment.

*Intent: This article shall secure the long-term health, purity, and freedom of the County’s food system, from the soil to the table, in full alignment with God’s natural design and the right of the People to nourish themselves safely and honestly.*

### **Article 80 – Protection of the Lawful Sale and Consumption of Raw Food and Beverages**

We the People of Washoe County, under this Bilateral Social Compact Agreement and in accordance with God’s law and common law, declare that the right to produce, sell, purchase, and consume raw, unpasteurized food and beverages shall be fully protected and unrestricted by government interference.

Accordingly:

1. The lawful sale, exchange, or distribution of raw and unpasteurized food or beverages—including but not limited to raw milk, cheeses, juices, fermented items, honey, and other naturally preserved or untreated foods—shall be permitted without government regulation, restriction, or licensing.
2. County or State health departments, or any regulatory agency, have no lawful jurisdiction over private farmers, ranchers, homesteaders, or food producers in the handling or sale of such foods.
3. All raw foods and beverages sold publicly shall carry a clear expiration or “best by” date, as determined by the producer using common sense, safety awareness, and accountability.
4. The People retain the inherent right to make their own health decisions regarding food consumption, including traditional, farm-direct, and unprocessed options, free from coercion, misinformation, or administrative overreach.

5. Any effort by corporate, government, or NGO entities to prohibit, criminalize, or suppress raw food sales, or to harass small producers under false pretense of safety, shall be treated as:
  - A violation of this Compact,
  - A breach of God-given liberty, and
  - A criminal act of economic discrimination and fraud, punishable by law.

*Intent: This article stands to preserve food sovereignty, freedom of choice, and the right to natural nourishment, and may not be overturned by commercial interests, federal mandates, or bureaucratic overreach.*

## **11. Environmental & Technological Policies**

- Article 81 – Bans geo-engineering, chemical trails, and weather modification
- Article 82 – EMF Regulations
- Article 83 – Energy hoaxes and scams
- Article 84 – Protection of Groundwater and Mineral Rights We the People of Washoe
- Article 85 – Public Access to Free Energy Technologies

### **Article 81 – Prohibition of Geo-Engineering, Aerosol Spraying, and Weather Modification Technologies**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and in accordance with God’s law and common law, hereby declare that the manipulation of weather and atmosphere through artificial or military technology is a violation of natural law, public health, and human sovereignty, and is strictly prohibited.

#### **1. Absolute Ban on Weather Modification and Geo-Engineering**

a. The use of geo-engineering, weather modification technology, radiation-based weather systems, electromagnetic atmospheric manipulation, and chemical or bio-chemical aerosol spraying of any kind is strictly prohibited within the airspace, lands, or waters of Washoe County, or within 1,000 miles of any air current, jet stream, or watershed that affects the County.

b. This includes but is not limited to:

- Stratospheric aerosol injection (SAI),
- Solar radiation management (SRM),
- Cloud seeding with metals or chemical agents,
- High-frequency active auroral research (HAARP)-style electromagnetic manipulation,
- Microwave-based weather control or surveillance platforms.

#### **2. Limited Agricultural Exception**

The only exception permitted under this Article is the use of localized, non-toxic, small-scale agricultural water seeding by individual farmers, provided it does not involve heavy metals, synthetic chemicals, or radiation-based technologies. Such use must be voluntary, transparent, and accountable to the local County Assembly.

### 3. **Enforcement and Accountability**

a. Any person, agency, government body, military entity, private contractor, or foreign actor found to participate in or facilitate such prohibited activities shall be deemed to have committed a crime against the People and a violation of the Nuremberg Code.

b. Penalties may include:

- Immediate cessation of operations,
- Seizure of equipment,
- Criminal prosecution, and
- Personal and financial liability for any damage to health, environment, or property.

### 4. **Oversight**

Local County Assemblies shall establish a Weather and Environmental Integrity Committee, composed of citizen scientists, weather experts, and community members, to:

- Monitor skies and air quality,
- Investigate reports of unauthorized atmospheric activity,
- Recommend enforcement action when violations occur.

*Intent: This Article is established to protect the skies, land, and people from unnatural manipulation, and to preserve the sovereignty of nature as created by God, for the welfare of this generation and those yet to come.*

## **Article 82 – Prohibition and Replacement of Harmful Electromagnetic Radiation (EMF) Technologies and Infrastructure**

We the People of Washoe and Humboldt Counties, under the authority of this Bilateral Social Compact Agreement and in alignment with God’s natural law, declare that the uncontrolled expansion of electromagnetic radiation (EMF) technologies poses a clear and present danger to public health, wildlife, and the natural environment.

Therefore, the use, installation, and operation of harmful EMF-emitting infrastructure and devices shall be strictly regulated or banned unless independently proven safe beyond reasonable doubt.

### 1. **EMF Emission Limits**

a. All devices, networks, and infrastructure emitting electromagnetic radiation—including but not limited to 2G, 3G, 4G, 5G, Wi-Fi, satellite, and any future wireless systems—shall not exceed 1/10th of the current federal safety exposure limits for human health and environmental safety.

b. These thresholds shall be subject to future reduction, based on independently peer-reviewed science, and shall be uninfluenced by telecom industry lobbyists, contractors, or federal regulatory capture.

### 2. **Prohibited and Restricted Technologies**

The following technologies are banned from new installation, expansion, or use, unless explicitly proven harmless through independent third-party scientific review:

- Smart electric, water, and gas meters

- Wireless routers, modems, smart home hubs
- Cell towers and antennas (macro, micro, or small cell) emitting high-frequency or pulsed radiation
- Satellite dishes and airborne or space-based EMF broadcasting systems
- Microwave-emitting streetlights, surveillance equipment, or biometric scanners
- EMF-based behavioral, tracking, or digital identity control systems
- Any implanted or wearable chip used for biometric, financial, or medical surveillance

### 3. **Replacement and Infrastructure Transition**

- a. All existing “smart” meters and wireless utility devices must be removed and replaced with safe, analog alternatives within 180 days of this Article’s enactment, at no cost to residents or property owners.
- b. Telecommunications and utility companies must submit full EMF safety and compliance reports to a County-approved Independent EMF and Radiation Review Board before any future technology deployment.
- c. Fiber optic and other shielded, hard-wired systems shall be prioritized as the default for all telecommunications and utility services to protect public safety while maintaining functionality.

### 4. **Enforcement, Oversight, and Penalties**

- a. No federal, state, international, or private entity shall circumvent this Article through:

- Emergency declarations
- Regulatory exemptions
- Industry preemption claims
- Contractual fine print or nondisclosure clauses

- b. Violations shall result in full liability, including:

- Civil restitution for proven harm to people, animals, or property
- Criminal prosecution in cases of willful negligence, cover-up, or coercion
- Permanent ban or revocation of operational licenses, franchises, or permits within the county

- c. Oversight and enforcement shall be entrusted to a citizen-led County EMF and Environmental Safety Board, accountable to the County Assembly and empowered to:

- Audit technologies in use,
- Investigate health complaints or reports of noncompliance,
- Issue cease-and-desist orders when threats are identified.

*Intent: This Article stands as a permanent protection of the God-given physical sovereignty of every man, woman, child, and living creature, and ensures that only technologies proven safe, natural, and life-affirming may operate within our communities.*

## **Article 83 – Immediate Moratorium on Scam Energy Projects and Accountability for Environmental Fraud**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, affirm our right to protect our land, health, and economy from deceptive, harmful, or unnatural energy practices.

Accordingly, the following mandates are established:

**1. Immediate Cessation of Speculative and Harmful Energy Projects**

All current and future building projects involving the following are hereby halted immediately:

- Industrial-scale solar farms that disrupt natural land use, wildlife, or agricultural capacity;
- Wind turbine installations, including those tied to federal subsidies or speculative investment schemes;
- Carbon dioxide or gas sequestration operations which interfere with natural atmospheric balances, water tables, or pose long-term geological risks.

No permits, grants, or construction may proceed unless proven to be:

- Scientifically sound,
- Economically beneficial to the local community, and
- Aligned with God’s law and this Compact.

**2. Accountability for Fraudulent or Coercive “Green Energy” Practices**

If solar companies or renewable energy firms have knowingly:

- Misrepresented costs, efficiency, or savings,
- Pressured or deceived residents into signing contracts, or
- Installed faulty or damaging equipment,

they shall be required to:

- Remove any equipment at their own expense if the property owner so requests,
- Fully compensate the injured party, including costs for repairs, lost energy, and contractual damages, and
- Pay fines or face legal action for consumer fraud, misrepresentation, and violation of this Compact.

**3. Oversight and Review**

A County Energy Integrity Panel shall be appointed by the County Assembly to:

- Investigate complaints,
- Audit prior installations and contracts,
- Approve or deny new proposals based on strict truth-in-energy standards.

*Intent: This Article ensures that energy solutions within Washoe County serve the People—not corporate agendas, false science, or coercive “green” profiteering—and that integrity, not ideology, governs our stewardship of the land.*

## **Article 84 – Protection of Groundwater Rights and Prohibition of Fraudulent Water Production Schemes**

We the People of Washoe County, under this Bilateral Social Compact Agreement and in harmony with God’s provision of natural resources, declare that access to clean, abundant, and naturally sourced water is an unalienable right, not a commodity to be manipulated, restricted, or exploited by government, corporate, or foreign entities.

### **1. Recognition of Primary Groundwater as a Protected Natural Resource**

- a. The primary groundwater beneath the surface of the earth—naturally pressurized, pure, and life-sustaining—is hereby recognized as a divine provision and public trust, not subject to private monopoly, federal seizure, foreign ownership, or speculative trading.
- b. All residents of Washoe County retain the natural right to access and draw from primary groundwater aquifers on their own land for personal, agricultural, and community use, subject only to reasonable measures of preservation and non-contamination.

### **2. Prohibition of Synthetic or Engineered “Water Solutions” and Deceptive Practices**

The following practices are hereby banned unless independently reviewed and approved by the County Assembly based on demonstrable benefit and safety:

- Atmospheric water harvesting devices promoted as replacements for ground wells;
- Chemically altered or synthetically produced “drinking water” sold under misleading green or scarcity-based marketing;
- Public-private partnerships or treaties that sell, lease, or divert local water supplies, including groundwater, to external entities;
- Any measure that denies, restricts, or adds financial barriers to the lawful drilling of private wells accessing primary groundwater, especially under false pretense of conservation or climate compliance.

### **3. Legal Protections and Enforcement**

a. Water is not a corporate asset, nor a tool of control. Any effort to privatize, tax, meter, or restrict access to natural groundwater in Washoe County is a violation of this Compact and a breach of natural law.

b. Any corporation, agency, or official found to:

- Misrepresent the availability of natural water,
- Install controlling devices without consent,
- Interfere with lawful well drilling or private water collection,

shall face:

- Civil penalties,
- Criminal prosecution if intentional fraud or coercion is proven, and
- Permanent ban from doing business within the county.

#### 4. **Oversight and Groundwater Protection Board**

A Groundwater and Water Integrity Board, appointed by the County Assembly, shall be established to:

- Maintain a public record of aquifer health and capacity,
- Review proposed technologies and projects for water production,
- Defend the People’s access to God-given water supplies against fraudulent schemes or foreign interference.

*Intent: This Article affirms that God has already provided all that is necessary for life, and the People shall not be denied or deceived into dependency on artificial scarcity. Water beneath our feet belongs to the People—not to bureaucrats, profiteers, or external powers.*

### **Article 85 – Guarantee of Public Access to Free Energy Technologies and Prohibition of Suppression or Control**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and in accordance with God’s law, do hereby affirm that all natural and divinely inspired forms of clean, abundant, and free energy are to remain fully accessible to the People without obstruction, monopolization, or commercial exploitation.

#### 1. **Recognition of Free Energy as a Public Right**

a. Any energy system or device that harnesses the natural, ambient, or radiant energy of the universe—whether through electromagnetic resonance, zero-point energy, Tesla-based technologies, or similar discoveries—shall be recognized as the property of the public domain, not of corporations, governments, or private patent holders.

b. Free energy technologies, once proven functional and safe, shall be freely accessible, distributed, and maintained for the benefit of all residents of Washoe County and the wider Republic, without taxation, licensing fees, or usage restrictions.

#### 2. **Prohibition of Suppression and Monopolization**

a. No corporation, government agency, private party, foreign power, or non-governmental entity shall be permitted to:

- Patent or restrict access to free energy technologies,
- Interfere with the manufacture, repair, or distribution of such technologies,
- Establish exclusive rights, profit-driven gatekeeping, or artificial scarcity through regulation or legal mechanisms,
- Destroy, suppress, buy out, or disappear inventors, documents, or research related to free energy systems.

b. Any such action shall be considered a criminal act of treason against the People and a violation of this Compact.

#### 3. **Mandated Local Development and Open Source Sharing**

a. The County Assembly shall support and facilitate local research, development, and education in free energy systems by individuals, cooperatives, or volunteer organizations.

b. All technologies developed under this protection shall be released in open-source form for peer review, community access, and lawful public implementation, provided they are:

- Safe for home and commercial use,
- Environmentally neutral or beneficial, and
- Consistent with this Compact and God’s law.

4. **Oversight and Accountability**

a. A Free Energy Stewardship Board shall be appointed by the County Assembly to:

- Monitor breakthroughs and submissions,
- Protect inventors and researchers from suppression or coercion,
- Promote transparency, public access, and proper safety review,
- Ensure equitable distribution infrastructure without utility monopolies or financial barriers.

b. Violators of this Article—including corporate actors, lobbyists, regulatory bodies, or foreign agents—shall be held personally and financially accountable and may face:

- Loss of all patents and exclusive rights,
- Civil and criminal penalties, and
- Permanent exclusion from doing business in the county or state.

*Intent: This Article secures the God-given promise of abundant energy for life, prosperity, and independence, and ensures that never again shall the People be enslaved by artificial energy scarcity, monopolies, or technological suppression.*

## **12. Faith, Social Policies & Protections**

- Article 86 – Peaceful, unfunded protesting
- Article 87 – Declares sanctuary cities and related policies unlawful in Washoe County
- Article 88 – Gender and Marriage According to Natural and Constitutional Law
- Article 89 – Faith-Based Qualifications for Public Office
- Article 90 – Prohibition of Secret Societies Engaged in Subversive or Occult Activity

### **Article 86 – Protection of Peaceful Protest and Prohibition of Funded or Violent Demonstrations**

We the People of Washoe and Humboldt Counties, in full agreement under this Bilateral Social Compact Agreement and in alignment with God’s law and common law, recognize that the right of peaceful protest is an essential expression of conscience and lawful dissent.

However, we also declare that funded, violent, or artificially manipulated protests—designed to incite division, destruction, or political disruption—are unlawful and will not be tolerated.

1. **Right to Peaceful Protest**

a. All men and women within the counties retain the unalienable right to peacefully assemble and protest, provided that such assembly causes no injury, loss, or harm to persons, property, or the peace of the community.

b. Peaceful protests must remain:

- Non-violent,
- Law-abiding,
- Respectful of public and private property, and
- Free of coercion, intimidation, or threat.

2. **Ban on Funded and Manipulated Protest Activities**

a. It is strictly prohibited for any person, group, or entity to fund, organize, or incentivize others to protest for compensation or political manipulation.

This includes, but is not limited to:

- Political parties or operatives,
- Non-Governmental Organizations (NGOs),
- Corporate or foreign sponsors,
- Tax-exempt foundations, lobbyists, or unelected bureaucrats.

b. Groups or individuals posing as grassroots activists but acting under hidden financial direction or coordinated agendas shall be deemed agents of fraud and social disruption.

3. **Enforcement and Penalties**

a. Any individual who knowingly funds, organizes, or participates in a paid or violent protest shall be subject to:

- A fine of no less than \$100,000 per incident,
- Imprisonment of up to five (5) years, and
- Permanent loss of public trust and office, if applicable.

b. Protesters engaging in violence, looting, vandalism, or threats shall be subject to immediate lawful arrest, held to bond conditions, and brought before a Grand Jury for trial.

4. **Oversight and Protection**

A County Assembly–appointed Public Integrity and Civil Harmony Board shall be established to:

- Investigate reports of funded or violent protests,
- Vet the origins of organized demonstrations,
- Protect lawful protestors’ rights, and
- Recommend prosecution of funders, instigators, and violent actors.

*Intent: This Article ensures that the sacred right to speak truth peacefully shall never be criminalized, while funded deception, violence, and disruption masquerading as protest shall be*

*exposed, punished, and prevented—preserving order, dignity, and lawful voice for all the People.*

## **Article 87 – Prohibition of Sanctuary City Policies and Enforcement of Constitutional Immigration Law**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and the Constitution for the Republic of the United States of America, affirm that all county laws and policies must align with national immigration laws, constitutional sovereignty, and the rule of law.

### **1. Ban on Sanctuary City Policies**

No city, municipality, department, agency, or official within Washoe County shall:

- Declare sanctuary status,
- Adopt policies that shield unlawful foreign nationals from legal accountability,
- Obstruct lawful cooperation with constitutional immigration enforcement, or
- Provide state or local benefits, housing, identification, or employment to individuals who are unlawfully present in the United States.

Any such actions are hereby declared unlawful, null, and void within this county.

### **2. Accountability for Aiding and Abetting**

Any individual, organization, government official, or entity that knowingly:

- Aids, shelters, transports, or conceals an unlawful foreign national, or
- Obstructs lawful due process related to immigration enforcement, is in violation of this Compact and the Constitution, and may be subject to:
  - Criminal prosecution,
  - Civil penalties, and
  - Removal from office or public service, upon conviction.

### **3. Distinction from Lawful Immigration**

This Article does not apply to lawful immigrants, refugees, or those navigating legal naturalization processes in good faith. It targets only those residing unlawfully and any attempts to undermine or bypass lawful immigration systems.

*Intent: This Article ensures that Washoe County remains a community rooted in law, national unity, and secure borders, and rejects all efforts to harbor unlawful activity under political pretense. Justice and compassion must never come at the cost of truth and constitutional order.*

## **Article 88 – Definition of Gender and Marriage According to Natural and Constitutional Law**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and the laws of nature and nature’s God, do affirm the following definitions and protections for the moral and social foundation of our community:

**1. Definition of Gender**

There are two distinct, God-created genders: male and female, each defined by immutable biological characteristics present at birth. These distinctions shall be recognized in all legal, educational, governmental, and social systems within Washoe County.

**2. Definition of Marriage**

Marriage shall be legally and lawfully recognized only as the union of one man and one woman, as originally instituted by God and upheld by the founding principles of this Republic.

**3. Protection of Children and Public Institutions**

a. No public institution—including schools, libraries, or government agencies—shall promote, fund, or endorse the teaching, normalization, or celebration of gender ideologies that contradict the biological reality of male and female or that undermine the traditional family structure.

b. Children shall be protected from exposure to sexually explicit, confusing, or ideologically driven materials or events that seek to influence their identity or moral development contrary to the principles outlined herein.

**4. Right to Personal Belief**

This Article does not prevent private individuals from holding personal beliefs or practices regarding gender or identity; however, such beliefs may not compel the People, public institutions, or legal systems to affirm, fund, or participate in them.

**5. Enforcement**

Any violation of this Article through policy, coercion, or public indoctrination shall be subject to lawful remedy, including:

- Public investigation and community hearings,
- Immediate removal of offending curriculum or policy, and
- Civil penalties or disqualification from public service where applicable.

*Intent: This Article safeguards the People’s right to uphold biological truth, moral clarity, and the God-given design of the family, ensuring that public law, education, and policy remain grounded in reality, not political or ideological manipulation.*

**Article 89 – Faith-Based Qualifications for Public Office**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and in covenant with Almighty God, do affirm that those entrusted with public office must be guided by righteous principles and unwavering moral integrity.

**1. Profession of Faith**

All candidates for public office within Washoe County must profess a sincere belief in the one true God and a living faith in His Son, Christ Jesus (Yeshua the Messiah)—the moral foundation of this Compact and the Constitution for the Republic of the United States of America.

**2. Evidence of Godly Character**

In addition to verbal profession, each officeholder must demonstrate a consistent pattern of life that reflects:

- Integrity, humility, and self-governance,
- A heart of service, not personal gain,
- Alignment with biblical truth and the teachings of Christ, and
- The evident fruit of the Spirit: love, joy, peace, patience, kindness, goodness, faithfulness, gentleness, and self-control.

### 3. **Ongoing Accountability**

Each officeholder shall remain accountable to:

- The People of Washoe County,
- The County Assembly, and
- God’s law as the supreme moral standard.

Should an officeholder fall into persistent unrepentant conduct contrary to these principles, the County Assembly shall initiate a public review and may pursue removal from office following due process.

*Intent: “To whom much is given, much shall be required.” This Article ensures that those entrusted with leadership in this County serve not as rulers, but as faithful stewards—walking humbly with God, upholding truth, and promoting justice for all.*

## **Article 90 – Prohibition and Expulsion of Secret Societies Engaged in Subversive or Occult Activity**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and in alignment with God’s law, do hereby declare that any secret society operating in darkness, engaging in occult practices, or promoting subversive, anti-American, anti-Christian, or ritualistic activity is a clear and present danger to the safety, sovereignty, and moral fabric of our community.

### 1. **Definition and Designation**

The following shall be deemed unlawful and seditious organizations:

- Any secret society that conducts rituals or oaths in secrecy or darkness,
- Organizations founded upon or promoting Satanic, Luciferian, occult, or antichrist ideologies,
- Groups such as, but not limited to, Skull and Bones, the Illuminati, or similar clandestine networks whose allegiances, aims, or activities undermine the People’s sovereignty, law, or divine authority.

Such groups are hereby designated domestic terrorist organizations within the jurisdiction of Washoe County.

### 2. **Mandate for Disbandment and Removal**

All such organizations, their affiliates, and members are given 30 calendar days from the date of ratification of this Article to:

- Cease all operations within Washoe County,
- Disband all related activity, and

- Vacate the county permanently.  
Failure to comply will result in immediate enforcement action.

### 3. **Enforcement and Penalties**

Any individual, group, or property found to be associated with the continued operation or concealment of such societies shall be subject to:

- Criminal charges of sedition, conspiracy, or terrorism,
- Imprisonment of no less than 10 years, and
- Total asset forfeiture, including organizational holdings, real estate, and digital property.  
County law enforcement, with the oversight of the County Assembly and People’s Grand Jury, shall ensure lawful enforcement of this mandate.

*Intent: This Article defends our God-given liberty, moral integrity, and transparent governance, ensuring that no group operating in secrecy, darkness, or evil intent will ever rule over or influence the free People of this county.*

## 13. **Criminal Justice & Protection**

- Article 91 – Human Trafficking & Child Abuse
- Article 92 – Designates human trafficking, child rape or kidnapping as capital crimes, imposing the harshest penalties on offenders, participants and facilitators.
- **Article A1 – Sanctuary City Policies and other Criminal Protection Schemes**
- **Article A2 – Equal Justice and Non-Discrimination**
- **Article A3 – Legal Accountability from Age Twelve**

### **Article 91 – Absolute Prohibition of Human Trafficking, Exploitation, and Unlawful Removal of Children**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and in alignment with God’s law, common law, and the Constitution for the Republic of the United States of America, do hereby declare the following:

#### 1. **Total Ban on Human Trafficking and Exploitation**

All forms of human trafficking are strictly prohibited within Washoe County. This includes, but is not limited to:

- Trafficking of men, women, or children for labor, sexual exploitation, ritual abuse, or organ harvesting;
- Acts of pedophilia or child sexual exploitation;
- Any form of slavery, involuntary servitude, or crimes against humanity.

#### 2. **Enforcement and Penalties**

Such crimes are considered capital offenses under this Compact and shall be prosecuted swiftly and to the fullest extent permitted by God’s law and the laws of this land.

Penalties may include:

- Life imprisonment or death,
- Permanent asset seizure,
- Public disclosure of offenders after lawful conviction,
- Disqualification from all public or private trust-based roles.

Judicial proceedings shall follow due process and be overseen by common law courts established under this Compact, with Grand Jury involvement where applicable.

### 3. **Protection of Parental Rights and Due Process**

No agency, including Child Protective Services (CPS) or equivalent entities, may remove a child from the care of a parent or guardian without lawful due process, including:

- Presentation of credible physical evidence of imminent harm,
- A sworn affidavit by a firsthand witness,
- Judicial review by a common law judge, and
- The right of the parent or guardian to legal counsel, jury trial, and appeal.

Any CPS agent, judge, or official who violates these due process protections shall be personally liable and subject to immediate suspension, prosecution, and civil restitution.

### 4. **Protection of the Innocent**

This Article stands as a permanent shield for the innocent and vulnerable. It recognizes the divine value of every human life and the sacred role of parents in protecting their children from state overreach and criminal exploitation.

*Intent: No compromise, no delay, no immunity. The People will not tolerate harm to the innocent, nor allow the abuse of government power under false pretenses. Justice shall be swift, lawful, and unshakable.*

## **Article 92 – Capital Crimes: Child Rape, Kidnapping, and Sexual Exploitation**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement and in accordance with God’s law, common law, and the foundational principles of the Republic for the United States of America, do hereby declare:

### 1. **Definition of Capital Offenses**

The following acts are deemed capital crimes within the jurisdiction of Washoe County:

- The rape, sexual abuse, or sexual exploitation of a child;
- The kidnapping, unlawful removal, or trafficking of a child for any purpose;
- Participation in, facilitation of, or financial benefit from any form of child sex slavery, child pornography, or child exploitation.

### 2. **Maximum Penalties**

Any individual or group found guilty of such offenses, following full due process of law, shall face the highest lawful penalties, which may include:

- Capital punishment or life imprisonment without the possibility of parole,
- Permanent seizure of all personal and affiliated assets,

- Public disclosure and lifetime ban from any public, educational, or caregiving role,
- Restitution to victims and their families.

### 3. **Scope of Accountability**

This Article applies not only to direct perpetrators, but also to:

- Accomplices, enablers, or financial backers,
- Government or institutional actors who conceal, delay, or obstruct justice,
- Media, corporate, or technological platforms that knowingly facilitate or profit from the exploitation of children.

### 4. **No Immunity or Loopholes**

No individual—regardless of title, office, agency affiliation, or corporate protection—shall receive immunity or diminished responsibility for crimes under this Article.

Violations of this kind are crimes against humanity and shall be prosecuted without exception.

*Intent: This Article stands as an unbreakable wall of protection around the children of Washoe County. It reflects our unwavering resolve to defend the most vulnerable, honor righteousness, and ensure that evil finds no refuge within our communities.*

## **Article A1 – Prohibition of Sanctuary City Policies and Criminal Protection Schemes**

### **Title: Absolute Ban on Sanctuary Status and Protection of Lawful Order**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, and in alignment with God’s law, common law, and the Constitution for the Republic of the United States of America, do hereby declare that no city, municipality, agency, or official within Washoe County shall enact, uphold, or tolerate any policy, ordinance, law, or practice that obstructs the enforcement of lawful justice or grants refuge to individuals engaged in criminal activity.

#### 1. **Ban on Sanctuary Policies and Practices**

a. It is unlawful for any political subdivision, government agency, or public official in Washoe County to:

- Declare or operate as a "sanctuary" jurisdiction for any class of lawbreakers, regardless of nationality or protected status;
- Refuse cooperation with lawful law enforcement agencies operating under constitutional jurisdiction;
- Shield or fail to report individuals known to be in violation of immigration, criminal, or moral law.

b. All such sanctuary declarations, policies, executive orders, or departmental practices are hereby null, void, and of no effect.

#### 2. **Criminal Liability for Aiding, Abetting, or Harboring Lawbreakers**

a. Any person, organization, or official who:

- Aids, abets, harbors, conceals, transports, or financially supports an individual known to be in violation of the law;
- Obstructs lawful investigation, arrest, or due process of such individuals;
- Intentionally interferes with constitutional enforcement efforts or attempts to codify unlawful sanctuary protections—  
shall be considered more culpable than the original offender and shall be subject to:
  - Prosecution for obstruction of justice, sedition, and conspiracy to violate this Compact;
  - Mandatory penalties including imprisonment, fines, and disqualification from any public or fiduciary role.

3. **Duty to Report and Cooperate with Lawful Enforcement**

All county employees, agencies, and residents are obligated under this Article to cooperate fully with lawful enforcement actions and to report any known violations, obstructions, or attempts to institute unlawful sanctuary protections.

4. **Enforcement and Penalties**

Violations of this Article shall result in:

- Immediate cessation of unlawful policy or conduct,
- Criminal and civil prosecution,
- Permanent removal from office for any public servant complicit in such actions,
- Asset forfeiture in cases of willful support of ongoing criminal activity.

5. **Protection of the Innocent and Law-Abiding**

This Article does not target lawful immigrants, peaceful individuals, or those who have completed just legal remedies. It is aimed exclusively at the unlawful shielding of lawbreakers and the systemic subversion of constitutional order.

*Intent: To safeguard Washoe County from criminal infiltration, government corruption, and policy-based lawlessness by outlawing all sanctuary-style protections for lawbreakers and holding those who create or uphold such schemes doubly accountable. Law must defend the innocent, not harbor the guilty.*

**Article A2 – Equal Justice and Non-Discrimination**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, in alignment with God’s law, the Constitution for the Republic for the United States of America, and the principle that all men and women are created equal, do hereby make unlawful all forms of prejudice, discrimination, or reverse discrimination in any sphere of public or civil life.

1. **Scope of Protection**

This Article applies to all individuals, organizations, and entities operating within Washoe County, including but not limited to:

- Government bodies and officials,
- Public and private employers,
- Educational institutions,
- Civil, judicial, and law enforcement agencies,
- Public services, businesses, and service providers.

**2. Prohibited Bases of Discrimination**

No person shall be denied employment, promotion, equal pay, benefits, housing, public service, justice, or lawful opportunity on the basis of:

- Race, ethnicity, or nationality,
- Sex, biological gender, or marital status,
- Age, physical or mental ability, or lawful medical status,
- Religion or lack thereof,
- Political beliefs or affiliations,
- Lawful exercise of freedom of speech or conscience,
- Socioeconomic status or past lawful occupation,
- Any other arbitrary or prejudicial factor unrelated to merit, skill, or lawful conduct.

**3. Equal Standards of Justice and Application of Law**

a. All laws, enforcement actions, judicial proceedings, and penalties must be applied equally without favoritism, leniency, or severity based on identity, affiliation, or status.

b. No person shall be above the law, and no person shall be targeted by the law for reasons unrelated to actual violations.

**4. Prohibition of Reverse Discrimination and Preferential Treatment**

a. Any policy, program, or practice granting benefits, advantages, or exemptions to one group while denying the same to another on the basis of the categories listed above shall be considered unlawful reverse discrimination.

b. Equal opportunity does not mean equal outcome; merit, skill, and integrity shall remain the lawful basis for advancement, service, and reward.

**5. Enforcement and Penalties**

a. Any individual, organization, or public servant found in violation of this Article shall be subject to:

- Fines of no less than \$50,000 per violation,
- Restitution to the injured party,
- Removal from office or termination of employment where applicable,
- Possible criminal prosecution for willful or systemic violations.

b. The County Assembly shall establish an Equal Justice Oversight Committee to investigate, review, and recommend enforcement action in all such matters.

*Intent: To secure an uncompromising standard of fairness, equality, and justice for all People within Washoe County, ensuring that neither prejudice nor reverse prejudice undermines employment, governance, public service, or freedom of speech. God is no respecter of persons, and neither shall this County show partiality in judgment or opportunity.*

**Article A3 – Legal Accountability from Age Twelve**

**Title: Adult Legal Responsibility for Persons Twelve Years and Older**

We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, God’s law, and the Constitution for the Republic for the United States of America,

do hereby establish that all persons age twelve (12) years and older shall be held fully responsible as adults under the law, except in matters concerning the lawful age of consent.

**1. Adult Legal Standing from Age Twelve**

a. Any person who has reached their twelfth birthday shall be considered legally accountable as an adult for purposes of:

- Criminal prosecution,
- Civil liability,
- Restitution for damages,
- Compliance with all laws, regulations, and ordinances of this County and the Republic.

b. This designation is for the purpose of ensuring full responsibility for one’s actions, understanding of right and wrong, and accountability to the People, without diminishing the legal protections of childhood where applicable.

**2. Preservation of Age of Consent Protections**

a. This Article does not alter or lower the lawful age of consent for sexual activity, which remains as separately established by law.

b. Sexual activity with any person under the lawful age of consent remains a criminal offense, regardless of this Article’s designation of legal accountability.

**3. Judicial and Enforcement Provisions**

a. Persons 12 years and older charged with crimes shall be tried in common law courts under the same legal standards as adults, with full due process rights.

b. Sentencing for those under 18 may take into account rehabilitative measures in addition to mandated penalties, except in the case of capital or high crimes as defined in Article 100.

**4. Restitution Requirement**

Where applicable, offenders aged 12 and above must restore what was taken, damaged, or lost, in full or sevenfold, in accordance with biblical restitution principles.

*Intent: To ensure that from the age of twelve, all individuals are held fully accountable for their actions under the law, fostering responsibility, moral awareness, and justice—while preserving the legal protections that guard against sexual exploitation and safeguarding the sanctity of the age of consent.*

**Article 93 – Immutable Covenant Clause**

Title: Unalterable Foundation of the Republic

We, the People, declare that this Bilateral Social Compact Agreement, its covenant with God, and all Articles herein, grounded in Yeshua the Messiah’s law, shall never be altered in any manner undermining their original intent, righteousness, or public benefit. Any attempt by individuals, governments, corporations, or foreign entities to reinterpret, amend, repeal, or nullify these Articles for evil or selfish purposes is deemed treason against God and the People and shall be prosecuted with maximum lawful penalty, including capital punishment if harm is proven systemic, deliberate, or intended to destroy the Republic’s sovereignty or faith foundations.

*Intent: To secure the sacred permanence of the People’s covenant with God and to guarantee that no future power—foreign or domestic—can undermine the righteousness and original meaning of this Compact.*

**Article 94 – Ban on International and Emergency Preemption**

Title: Prohibition of Foreign or Emergency Overrides

No treaty, international agreement, United Nations declaration, WHO mandate, WEF directive, federal emergency power, or foreign law shall have jurisdiction, authority, or enforcement power within Washoe County, Nevada State, or the Republic for the United States of America. Any attempt to impose such governance is declared null, void, unlawful, and an act of war against the People, punishable under the highest treason statutes of this Compact and God’s law.

*Intent: To reject the imposition of globalist, corporate, or foreign power structures that contradict the People’s sovereign self-governance and lawful independence.*

**Article 95 – Protection Against Incremental Erosion**

Title: Safeguard Against Gradual Tyranny

No executive order, administrative ruling, pilot program, regulatory waiver, reinterpretation, or incremental policy change shall alter, bypass, limit, or erode the protections, rights, and principles established herein. All agencies and assemblies must review all proposed actions for compliance with this Article. Violators attempting incremental erosion shall be permanently banned from public office or employment, imprisoned for no less than 25 years, and liable for seven times the damages caused.

*Intent: To defend against slow or disguised usurpations of liberty by embedding immediate and enforceable resistance to all gradual forms of tyranny.*

**Article 96 – Swift Justice and Penalty Clause**

Title: Non-Negotiable Swift Justice Provision

All acts of treason, sedition, human trafficking, child exploitation, government corruption, infiltration, or attempts to subvert this covenant shall be prosecuted within 30 days of indictment. Judges, juries, and enforcement officers are mandated by God’s law to administer swift,

uncompromising justice, ensuring such evils never gain foothold. Any individual obstructing, delaying, or watering down justice in these matters shall be deemed complicit and prosecuted under identical charges.

*Intent: To eradicate the hidden allegiances and satanic influences that seek control over governance, education, or justice through secrecy and deception.*

### **Article 98 – Generational Education Mandate**

Title: Perpetual Teaching of Truth and Freedom

All educational institutions within the Republic shall teach, without omission or distortion:

- The history of the Republic’s covenant with God
- The unalienable rights of mankind
- The Constitution and Social Compact Articles
- Critical thinking, discernment, and spiritual warfare fundamentals
- The tactics of tyrants and Satan throughout history

Any educator, board, or institution omitting, falsifying, or manipulating this education shall be permanently barred from teaching, fined seven times their compensation, and publicly discredited. This ensures each generation upholds and defends these truths with wisdom and courage.

*Intent: To instill in future generations a deep and accurate understanding of truth, liberty, and spiritual vigilance so they may preserve and defend the Republic.*

### **Article 99 – Eternal Jurisdiction of Yeshua’s Law**

Title: Final Authority of Christ the King

We, the People, declare that Yeshua the Messiah is the supreme Lawgiver, Judge, and King over Washoe County, Nevada State, and the Republic for the United States of America. His law, righteousness, and mercy supersede all human authority. No future assembly, court, or individual shall claim lawful right to override, nullify, or rebel against His truth without incurring the full weight of earthly and heavenly justice. This Article stands eternal as our national covenant seal with God.

*Intent: To declare the supreme and unchanging authority of Christ over the land, the law, and the People—forever securing our foundation in divine sovereignty.*

These Articles shall be inserted as the final safeguard provisions of your Bilateral Social Compact Agreement to ensure its permanence, unbreachability, and righteous dominion for generations to come.

## **15. Crime and Punishment Standards**

By way of Biblical, Constitutional, and Natural Law Foundations for Justice  
We the People of Washoe County, under the authority of this Bilateral Social Compact Agreement, the Holy Scriptures, the Constitution for the Republic for the United States of America, the Nuremberg Code, and the Law of Nations, establish the following lawful framework for crime classification and mandatory punishment:

**1. Capital Offenses – Punishable by Death (subject to full due process and Grand Jury trial)**

Crimes qualifying as capital offenses include:

- Premeditated murder or assassination
- Rape or sexual abuse of a child or incapacitated person
- Human trafficking or slavery
- Ritual abuse or satanic sacrifice
- Treason, sedition, or attempt to overthrow lawful government

## Conclusion of Articles

\*Clause: This “County Assembly” of Washoe county, Nevada state, has the ability to make changes or amend this Bilateral Social Compact Agreement as needed upon a three quarter majority vote.

We the People understand that our role in the Social Compact is to live up to this agreement, accept consequences when we do not, and continue to work to become a more responsible People and contributor(s) to society. We understand that we have a right to voice our opinion about any rule, expectation, or consequence at any time. We do accept that once they have been established, it is our responsibility to be accountable to them, or accept the consequences. Consequences are as follows: The bonds and oaths that give you the title and position in office require you under Constitutional Compliance to uphold this Social Compact. We have the right to hold you accountable in both official and private capacity. If you trespass on these rights of the People, we have the right and the duty to seek lawful action and to follow due process of law to attain justice.

## Conclusion

We, the People, of Washoe County, agree to uphold this Bilateral Social Covenant, adhering to its rules under God’s law and common law, accepting consequences for breaches, and retaining liberty and the right to propose amendments. Official breaches face lawful consequences via common law due process. Amendments require a three-quarters vote, adhering to covenant principles. If there be conflict in this Bilateral Social Covenant, the county supersedes the city because the city lies within the county. Therefore, the lawfully elected authority of the county supersedes that of the city.

## A-2. Important Exclusions

- Any gender-neutral, inclusive-language, progressive, or ideologically revised editions
- Any translation that redefines sin, judgment, repentance, hell, Satan, demons, or the exclusive Lordship of Jesus Christ

### **A-3. Canon Boundary Clause**

Nothing in this Appendix shall be construed to expand, alter, or redefine the canon of Holy Scripture. The **Old and New Testaments alone constitute canon**. Non-canonical writings are referenced solely for historical testimony, instruction, and spiritual discernment.
