

Satan's and his deep state's future strategies and tactics to undermine

Abstract

Purpose & Scope

Purpose.

Scope.

This brief addresses seven strategic domains:

1. Manipulating interpretation and application (especially judicial and enforcement capture)
2. Psychological and cultural warfare (propaganda, division, infiltration)
3. Legal, political, and administrative tactics (preemption, emergency powers, incremental erosion)
4. Economic and technological warfare (attrition, surveillance, digital control systems)

5. Spiritual and moral strategies (targeted spiritual attack, temptation and compromise of leadership)
6. Long-term global integration strategies (jurisdiction redefinition, generational disruption)
7. Destabilization to force “rescue” by centralized global governance

What this is not.

This is not a partisan manifesto, not a prediction of specific dates or persons, and not a call to panic. It is a preparedness and discernment briefing.

Foundational Premise

1. **The enemy targets covenant order by attacking authority, truth, unity, and obedience.**
A Covenant Republic stands or falls on whether leadership and people remain submitted to God’s authority and moral law. Therefore, the primary attack is not merely against policies, but against the spiritual foundations that make righteous governance possible.

 4. **Legal structure alone cannot sustain covenant governance.**
Even the strongest articles and safeguards can be neutralized if leaders are corrupted, the people are demoralized, discernment collapses, or fear overrides obedience. Covenant endurance requires ongoing spiritual discipline: repentance, prayer, truth-telling, courage, and unity grounded in God.

1. **Judicial Subversion**
 - Appoint or corrupt judges who reinterpret plain meanings under *legalese*, international treaties, administrative law doctrines, or by declaring articles “unconstitutional” in the fabricated courts they control.

 - Refuse to enforce protective articles while hyper-enforcing punitive or irrelevant provisions, thus undermining public confidence in the Compact’s effectiveness.
