## OATH OF ALLEGIANCE

*(Covenant Authority, Moral Qualification, and Public Trust)*

### I. Affiant Identification

I, \_\_\_\_\_, a Living Man/Woman, do hereby reclaim my lawful status as a **State Citizen**, and affirm that I am a Citizen (b) of the United States of America, lawfully natural-born or lawfully settled upon the \_\_\_\_\_ free-State.

### II. Titles of Nobility and Divided Allegiance Prohibition

I affirm that I hold **no titles of nobility nor honour**, foreign or domestic, hereditary or conferred, explicit or implied, including any rank, registry, accreditation, or status prohibited under the **original Thirteenth Amendment** to the Constitution of the United States of America.

### III. Prohibited Affiliations and Disqualification

I affirm that I have taken **no oaths, vows, covenants, initiations, pledges, or obligations—past or present, open or concealed—** to any authority, society, order, religion, ideology, philosophy, movement, or association that establishes a rival, parallel, concealed, or superior authority in opposition to Almighty God, the Lordship of Jesus Christ, the Holy Bible, the original organic Constitution of the united States of America prior to 1860, or the original organic **de jure Republic**.

Such prohibited affiliations include, without limitation: all secret societies and oath-bound fraternities; Freemasonry in all rites and appendant bodies; Jesuits; Scottish Rite, York Rite, Shrine, Eastern Star, and all men's and women's Masonic organizations; communism; Marxism; socialism; collectivism; Sharia law and its courts; Islam as a governing or legal system; and all non-Christian religions or corrupted or misrepresented Christian sects whose doctrines or practices conflict with the Gospel of Jesus Christ.

### IV. Past Affiliation, Renunciation, and Deliverance

In the event that I have **ever** been associated, initiated, instructed, influenced, or affiliated—formally or informally, knowingly or unknowingly—with any such prohibited authority, belief system, organization, or covenant, I acknowledge such involvement as **spiritual compromise and unlawful divided allegiance**.

Accordingly, I do hereby **fully, publicly, and irrevocably renounce**:

- Satan (the adversary);
  - all fallen angels and demonic spirits;
  - all demonic influences, attachments, assignments, deceptions, oppressions, and strongholds;
- and
- every related oath, vow, covenant, initiation, dedication, agreement, title, benefit, or obligation—spoken or unspoken, written or unwritten—

declaring all such agreements **null, void, canceled, and without force or effect**, now and forever.

I affirm that I have **confessed** such prior involvement verbally and in writing; have **repented** before Almighty God; have **accepted Jesus Christ as Lord**; and have **received the Holy Spirit** as my sole spiritual authority and covering.

I further affirm that **Biblically ordered deliverance** has been completed through **prayer and fasting**, assisted by **mature believers gifted in spiritual discernment and deliverance**, and in the presence of **not fewer than two witnesses**, whose attestations are attached. I acknowledge that any failure to complete or truthfully disclose any portion hereof constitutes **covenantal fraud** and renders this oath **void ab initio**. See Appendix A.

## V. Attestation

I do solemnly swear (or affirm) before Almighty God that the foregoing is true and correct. I take this oath freely, without duress, and of my own volition, agreeing to be bound by its terms, consequences, and penalties.

### Constitutional Authority — Article VI

Article VI of the Constitution for the United States / Constitution of the United States (synonymous) provides:

“The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution; but no religious *\*[denominational]* Test shall ever be required as a Qualification to any Office or public Trust under the United States.”

### \*Moral and Scriptural Foundation (Clarifying Clause)

The “no religious test” prohibition at a national level, is understood and affirmed to prohibit **denominational establishment**, not to remove moral, covenantal, or allegiance-based qualifications of leaders historically recognized as necessary to preserve a republican form of government.

Historically, States require a religious test to hold office. This guards our Republic as our

founders' writings understood the need of a religious and moral People to insure the perpetuity of our form of government. See "... without imposing or endorsing a national religion, do hereby continue the adoption of the accurate "Holy Bible" as divine law and the fundamental basis of law form." (Declaration of Sovereign Intent c. November 14, 2010 - Notice of Abolishment Section I.)

Accordingly, I affirm that my duties in office are exercised under God and in covenant with the People, and that the supreme written moral authority governing my conduct is:

the **Holy Bible**, consisting of the Old and New Testaments, as preserved through the faithful **Hebrew, Aramaic, and Greek manuscript traditions** and accurately rendered in **historically orthodox translations**, as the foundational source of law, morality, justice, and governance;

together with the **historical witness of certain non-canonical writings**, received **not as Scripture**, but as supplemental testimony for instruction, warning, and spiritual discernment—particularly concerning the nature, methods, deceptions, and judgment of Satan, fallen angels, and demonic powers—including:

- **1 Enoch**
- **Jubilees**
- **The Testament of the Twelve Patriarchs**
- **The Wisdom of Solomon**
- **Sirach (Ecclesiasticus)**

all of which are subordinate to, and may neither amend, supersede, nor redefine, the canon of Holy Scripture. See Appendix B

## A-3. Canon Boundary Clause

Nothing in this Appendix shall be construed to expand, alter, or redefine the canon of Holy Scripture. The **Old and New Testaments alone constitute canon**. Non-canonical writings are referenced solely for historical testimony, instruction, and spiritual discernment.
